Karl W. Schuhman died on or about April 12, 2011.

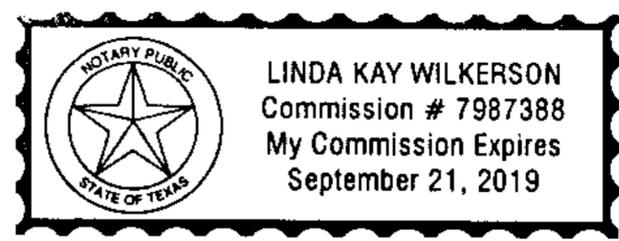
\$171,830.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.

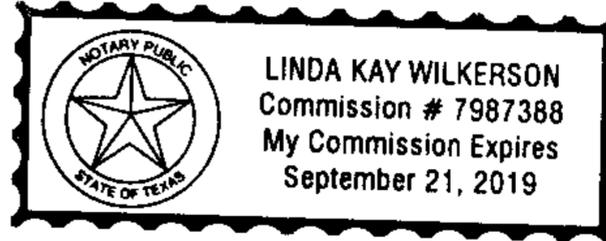
