For ad valorem tax purposes only, the address for the above described property is 2973 Brook Highland Drive, Birmingham, AL 35242.





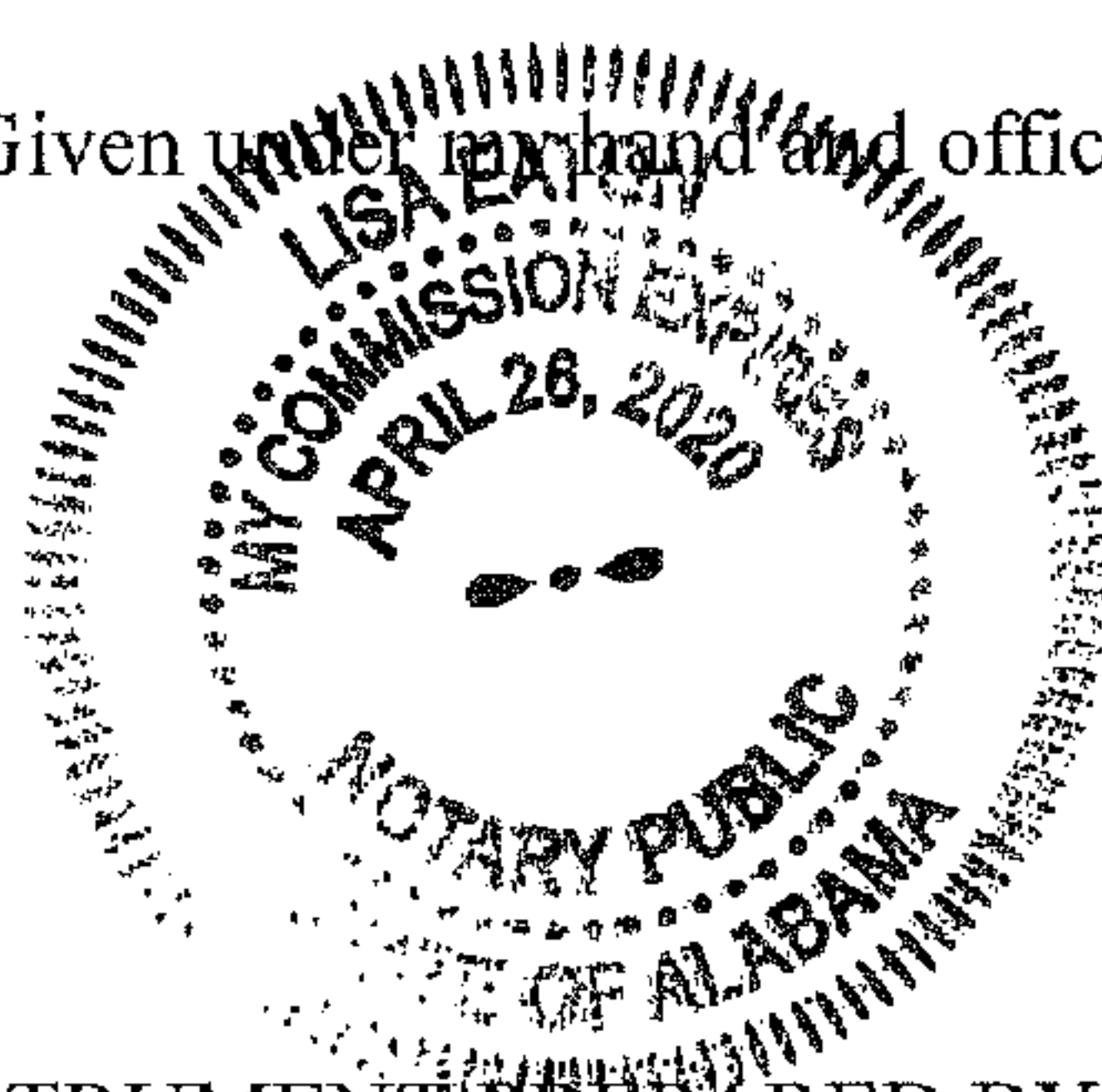
