For ad valorem tax purposes only, the address for the above described property is 165 Sharpe Street, Sterrett, AL 35147.

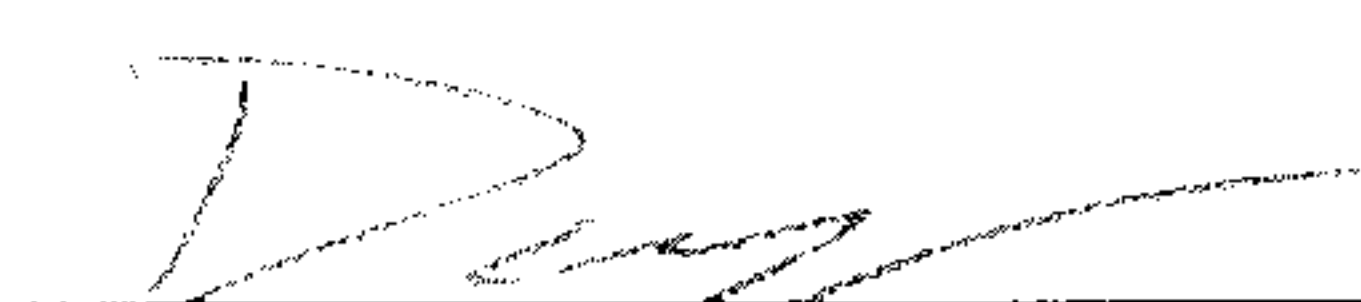

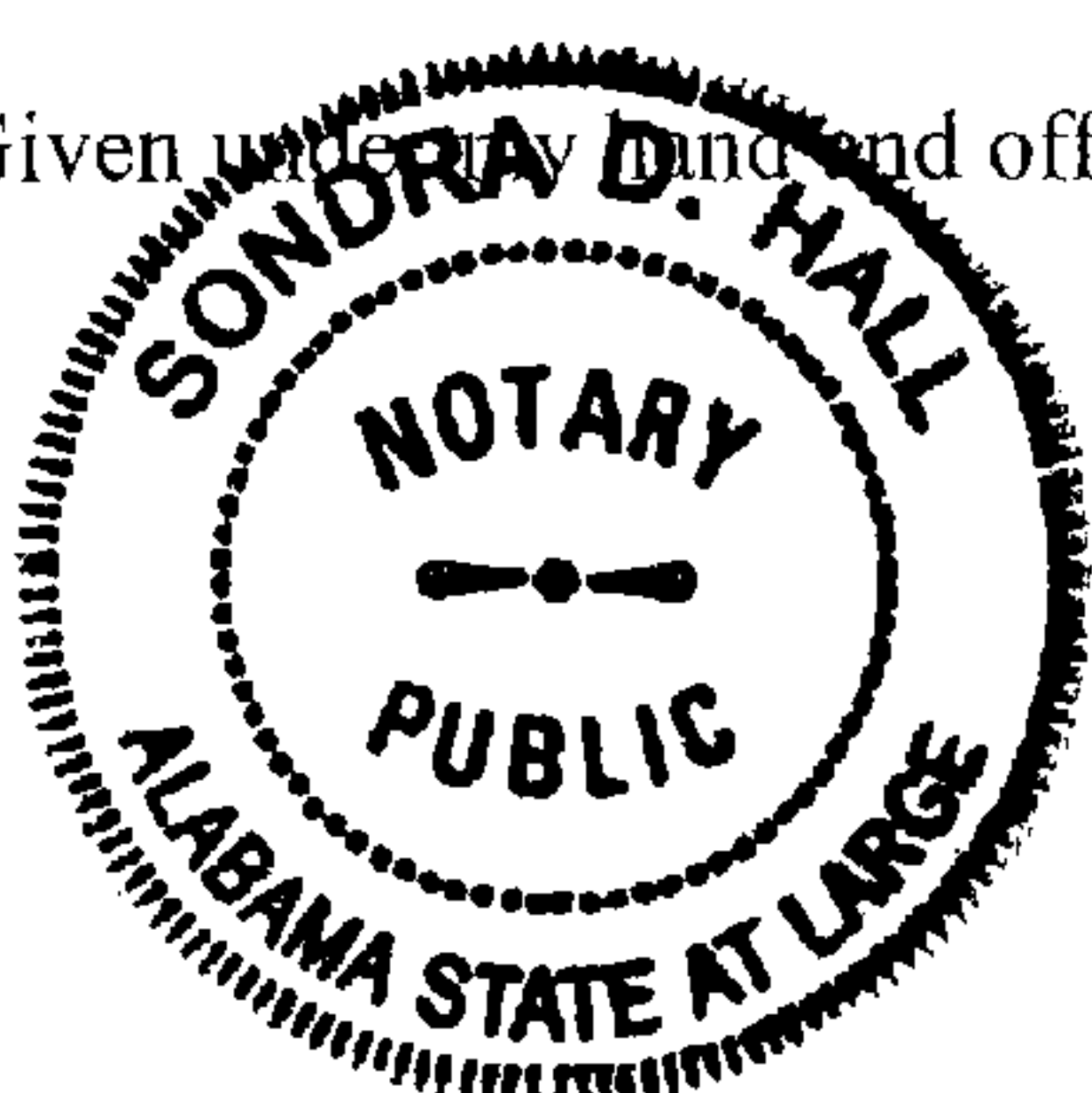
