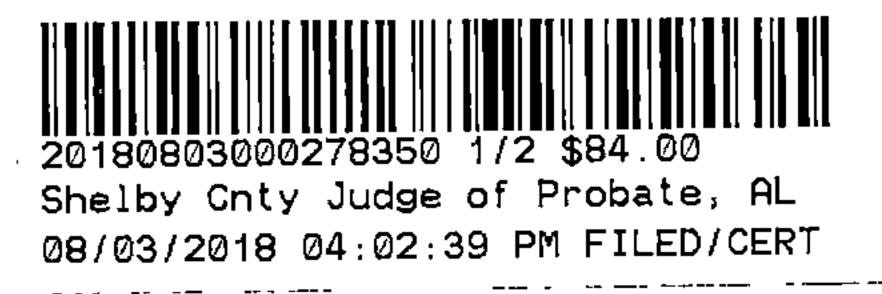

2. Except as otherwise expressly amended hereby, the Articles of Incorporation of the Corporation is and shall remain in full force and effect.

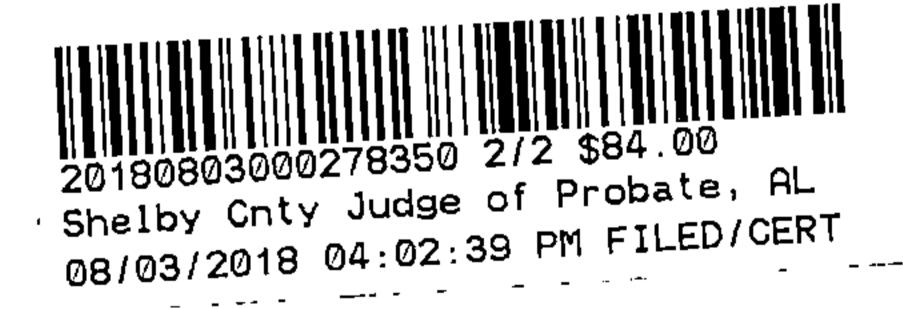
