ORDINANCE NO. 491

AN ORDINANCE VACATING A PORTION OF AN EASEMENT AT EAGLE POINT

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PELHAM, ALABAMA, AS FOLLOWS:

- **Section 1.** It is hereby established the City of Pelham, an Alabama Municipal Corporation, has certain interests pursuant to a 20' wide easement located in Griffin Park at Eagle Point Sector 2 Phase 1 as described and recorded in Deed Book 312 Page 523 in the Office of the Judge of Probate, Shelby County, Alabama; and
- **Section 2.** The City of Pelham has been requested to release its interests in a portion of said 20' wide easement and has determined it has no active facilities located in said portion of easement and it has no plans to install facilities therein; and
- **Section 3.** The City Council of Pelham, Alabama, to the extent that it has the legal authority to do so, to hereby RELEASE FOREVER its interest in said portion of easement described in the attached Exhibit A and Map, both made a part hereof, and to authorize the mayor, on behalf of the City of Pelham, to execute the VACATION OF EASEMENT documents.
- **Section 4.** This Ordinance shall become effective upon its passage and publication or posting as required by law.



EXHIBIT A – LEGAL DESCRIPTION

An existing 20' easement as recorded in Deed Book 312 Page 523 in the Office of the Judge of Probate in Shelby County, Alabama and being situated in the SE ¼ of the NE ¼ of Section 7, Township 19 South, Range 1 West, Shelby County, Alabama and being more particularly described as follows:

Commence at a ½" rebar capped EDG at the SW corner of Lot B-149 of Griffin Park at Eagle Point Sector 2 Phase 1 as recorded in Map Book 48 Page 98A through 98E in the Office of the Judge of Probate in Shelby County, Alabama; thence N 7°42'45" W along the west line of Lot B-149 a distance of 52.39 feet to a point on the south line of a 20 foot easement as recorded in Deed Book 312 Page 523 in said county, said point being the POINT OF BEGINNING; thence continue along the last described course a distance of 20.12 feet to a ½" rebar capped EDG on the north line of said easement and the north line of said 1/4-1/4 section; thence N 88°32'13" E along the north line of said easement and said 1/4-1/4 section a distance of 12.79 feet to a 3" capped pipe; thence continue along the last described course leaving the west line of Lot B-149 a distance of 36.66 feet to the east line of said easement; thence S 1°27'47" E along the east line of said easement a distance of 20.00 feet to the south line of said easement; thence S 88°32'13" W along the south line of said easement a distance of 47.26 feet to the POINT OF BEGINNING.
