MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, August 25, 2016, Carol D Moore, A Single Woman, Mortgagor, did execute a certain mortgage to Mortgage Electronic Registration Systems, Inc. as nominee for Salter Mortgage Group its successors and assigns, which said mortgage is recorded in Instrument No. 20160825000308120, in the Office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, on July 2, 2018, the day on which the foreclosure sale was due to be held under the terms of said notice at 12:56 o'clock am pm between the legal hours of sale, said foreclosure was duly and properly conducted and Franklin American Mortgage Company did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Columbiana, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of Franklin American Mortgage Company in the amount of **ONE HUNDRED THIRTY-ONE THOUSAND ONE HUNDRED EIGHTEEN DOLLARS AND NO CENTS (\$131,118.00)** which sum the said Franklin American Mortgage Company offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said Franklin American Mortgage Company; and
