## PERMISSIVE USE AGREEMENT

And John R. Porterfield, Jr. & Julie C. Porterfield, as owner of the property adjacent to the above-referenced property, and described as follows:

Lot E, according to the Map of Brook Ridge Estates, as recorded in Map Book 17, Page 133, in the Office of the Judge of Probate of Shelby County Alabama.

WHEREAS there is an encroachment on the adjacent side of said Lot F by a gazebo from Lot E and further evidenced on the survey attached hereto and incorporated as Exhibit "A".

WHEREAS the parties are desirous of creating an agreement between themselves that the area of encroachment by said gazebo shall be allowed for as long as John R. Porterfield, Jr. & Julie C. Porterfield shall own said Lot E or upon being given 60 days notice to remove said gazebo by Daryl Hurley White & Pamela Ann White. If said gazebo is not removed within sixty days of being provided notice, Daryl Hurley White & Pamela Ann White shall have the right to remove said fence and John R. Porterfield, Jr. & Julie C. Porterfield shall hold harmless Daryl Hurley White & Pamela Ann White from any and all liability and/or damages from the removal of said fence. This Agreement shall pass to the heirs and/or assigns of Daryl Hurley White & Pamela Ann White and the heirs and/or assigns of John R. Porterfield, Jr. & Julie C. Porterfield, however, if said fence is removed, it shall not be reinstalled on Lot F and this Agreement shall be terminated. Further, John R. Porterfield, Jr. & Julie C. Porterfield, her heirs and/or assigns, shall not claim any interest in the portion of Lot F on which said fence encroaches, and it is agreed and acknowledged by all parties herein that the permissive use of the gazebo shall never ripen into a claim for adverse possession.
