WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Two Hundred Forty-Six Thousand Nine Hundred and 00/100 Dollars (\$246,900.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

Jessica Anne Burford, an unmarried woman and Amanda Grace Kellar, an unmarried woman

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Steven Kurt Gardner and Laura Herring Gardner

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 440, according to the Survey of Windstone IV, as recorded in Map Book 27, Page 55, in the Probate Office of Shelby County, Alabama

\$234,555.00 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2018 ad valorem taxes not yet due and payable;
(2) all mineral and mining rights not owned by the Grantors; and
(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.
