FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of October, 2005, Lonzo Davis, a single person, executed that certain mortgage on real property hereinafter described to First Franklin a division of Nat. 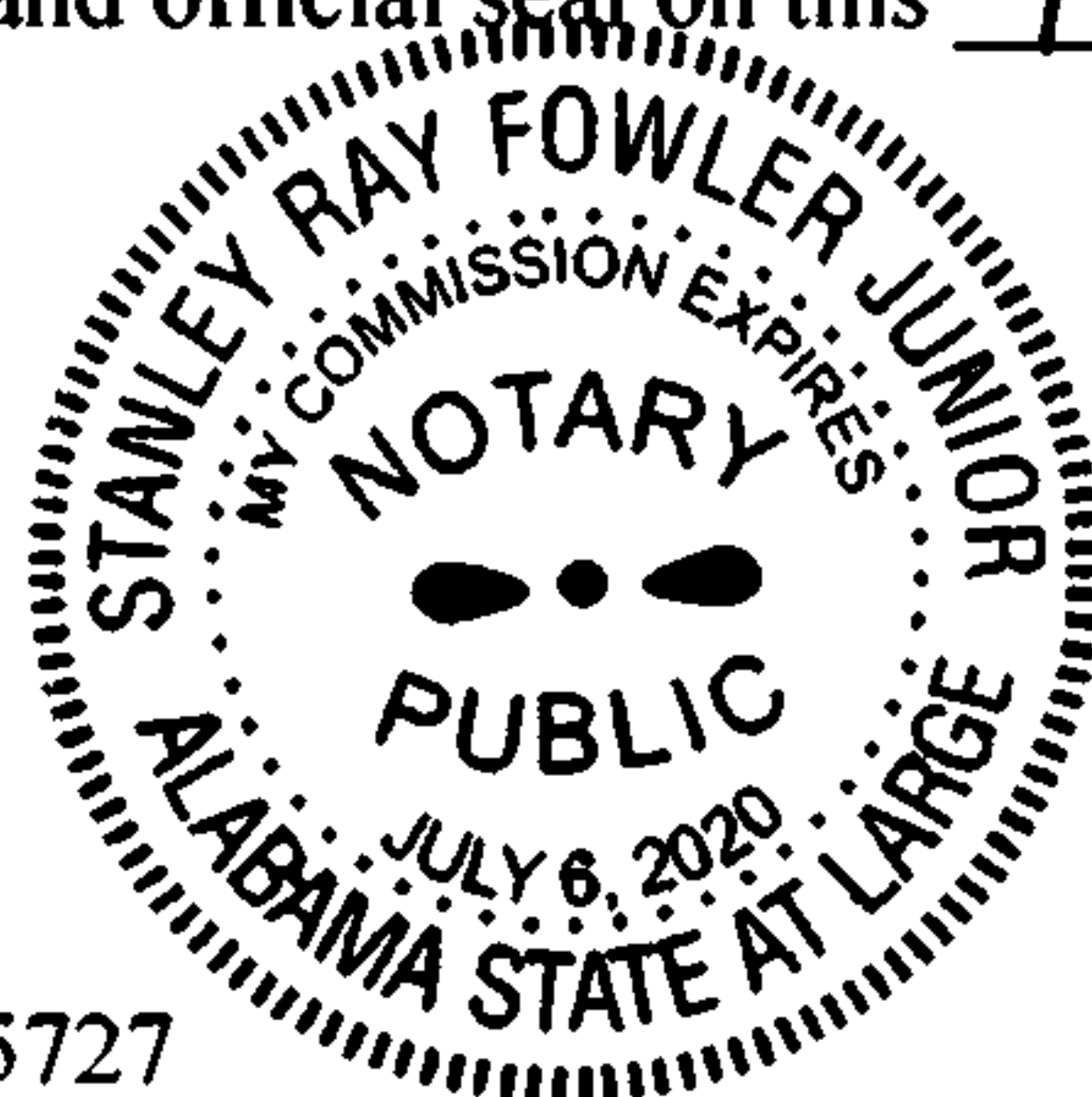
