FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 1st day of November, 2001, Perry Hodge, a married man and wife, Donna Hodge, executed that certain mortgage on real property hereinafter described to Long Beach Mortgage Company, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 2001-51882; having been modified by Loan Modification Agreement recorded in Instrument Number 20070605000260640; Order of Default Judgment recorded in Instrument Number 20150209000040940, said mortgage having subsequently been transferred and assigned to U.S. Bank, N.A., a successor Trustee to Wachovia Bank, N.A. (formerly known as First Union National Bank) as Trustee for Long Beach Mortgage Loan Trust 2001-4, by instrument recorded in Instrument Number 20061222000625360, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, U.S. Bank National Association, as Trustee, Successor in Interest to Wachovia Bank, National Association, (formerly known as First Union National Bank) as Trustee, for Long Beach Mortgage Loan Trust 2001-4 was the highest bidder and best bidder in the amount of One Hundred Four Thousand And 00/100 Dollars (\$104,000.00) on the indebtedness secured by said mortgage, the said U.S. Bank National Association, as Trustee, Successor in Interest to Wachovia Bank, National Association, (formerly known as First Union National Bank) as Trustee, for Long Beach Mortgage Loan Trust 2001-4, by and through Red Mountain Title, LLC as auctioneer conducting said sale for said Transferee, does hereby grant, bargain, sell and convey unto U.S. Bank National Association, as Trustee, Successor in Interest to Wachovia Bank, National Association, (formerly known as First Union National Bank) as Trustee, for Long Beach Mortgage Loan Trust 2001-4 all of its right, title, and interest in and to the following described property situated in Shelby County, Alabama, to-wit:

Commence at the Northwest corner of the SE 1/4 of Section 24, Township 18 South, Range 1 East, Shelby County, Alabama and run thence southerly along the West line of said quarter a distance of 1,154.57 feet to a point; Thence turn 90 degrees 00 minutes 00 seconds left and run easterly 349.12 feet to a point; Thence turn 90 degrees 00 minutes 00 seconds right and run southerly 297.34 feet to a steel pin corner and the point of beginning of the property being described; Thence turn 04 degrees 45 minutes 29 seconds right and continue southerly 310.00 feet to a steel pin corner; Thence turn 85 degrees 14 minutes 17 seconds right and run westerly 210.00 feet to a steel pin corner on the East margin of Merrywood Lane, a gravel surfaced public road; Thence turn 94 degrees 43 minutes 50 seconds right and run northerly along the said East margin of said road 310.00 to a steel pin corner; Thence turn 85 degrees 16 minutes 24 seconds right and run easterly 210.17 feet to the point of beginning.

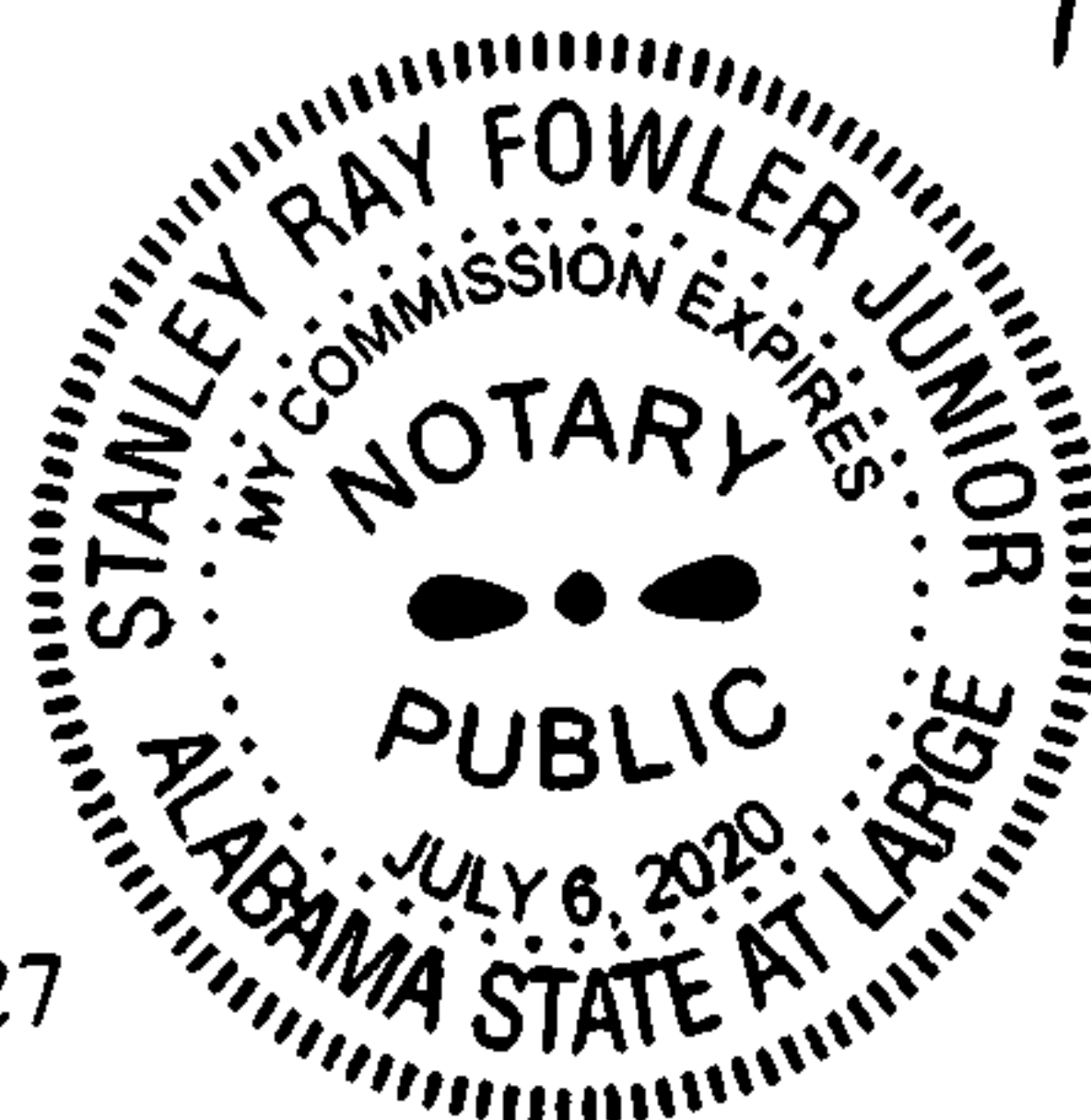
