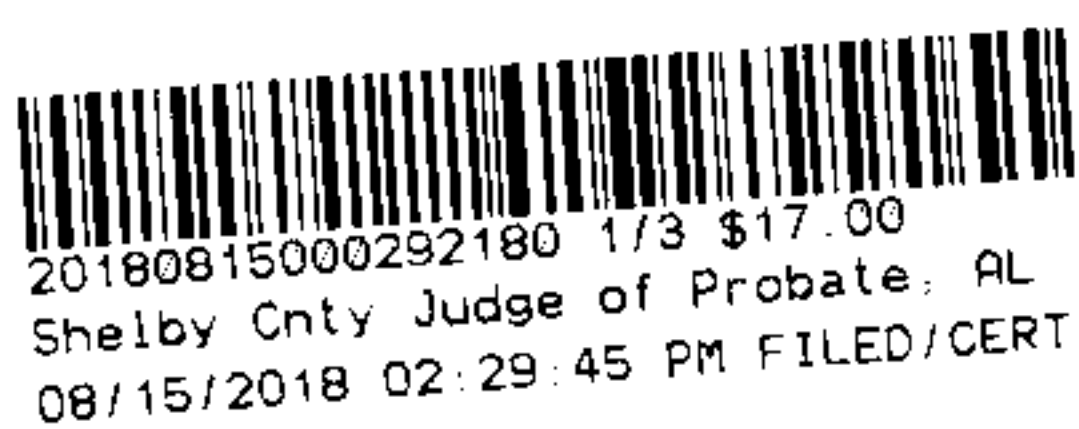
5. With respect to real property, the Trustee is authorized under the Trust Agreement to sell, transfer, assign and convey any of the property of the trust or any interest therein.

7. This Certification of Trust is being made to certify the powers of the Trust relating to real property. Statements herein are made as sworn statements and may violate state and federal law if falsely made.



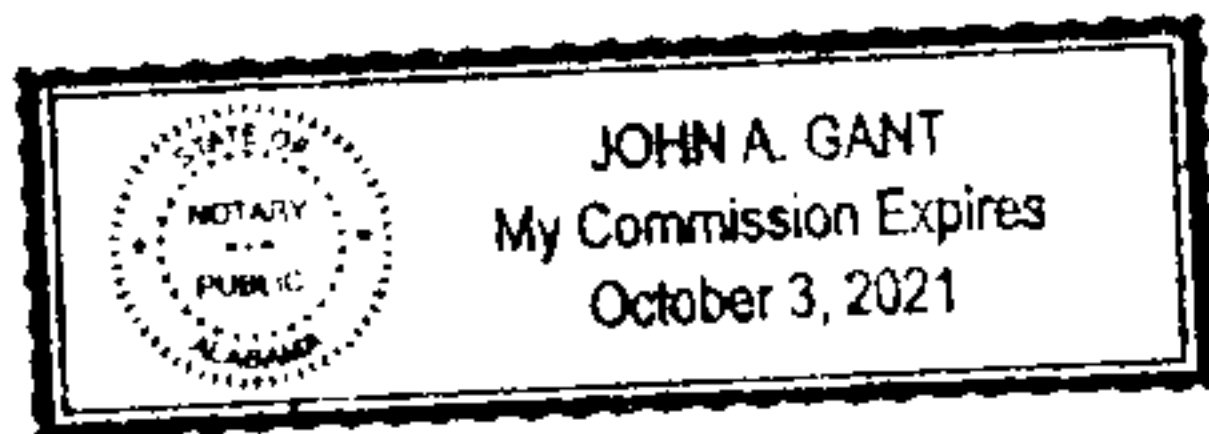

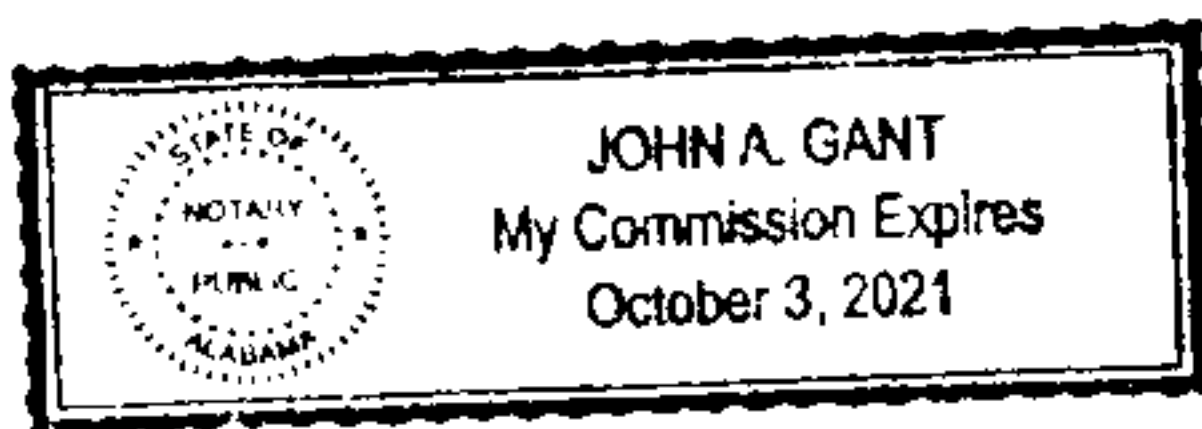
