That for and in consideration of **TWO HUNDRED THIRTY TWO THOUSAND FIVE HUNDRED AND NO/100 (\$232,500.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **DUSTY W. WADE, a single man, and JOY E. WADE, a married woman**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **PATRICIA CANTAVESPRE, AS TRUSTEE OF THE PATRICIA CANTAVESPRE REVOCABLE TRUST AGREEMENT and MICHELLE RUSSO BAIRD**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 2220, according to the Survey of Riverbend at Old Cahaba Phase 2, as recorded in Map Book 45, Page 32, in the Probate Office of Shelby County, Alabama.

6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 45, Page 32.




