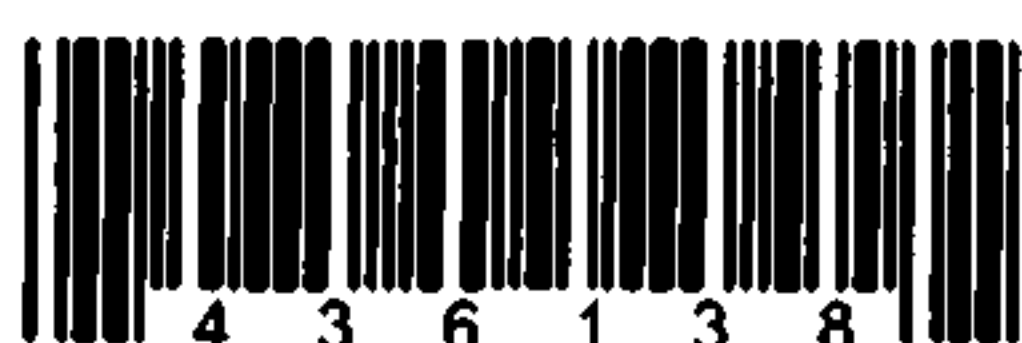
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of June, 2004, Jean C Mellard, a single woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for America's Wholesale Lender, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20040701000363750, said mortgage having subsequently been transferred and assigned to Ditech Financial LLC, by instrument recorded in Instrument Number 20180604000196310, in the aforesaid Probate Office ("Transferee"); and

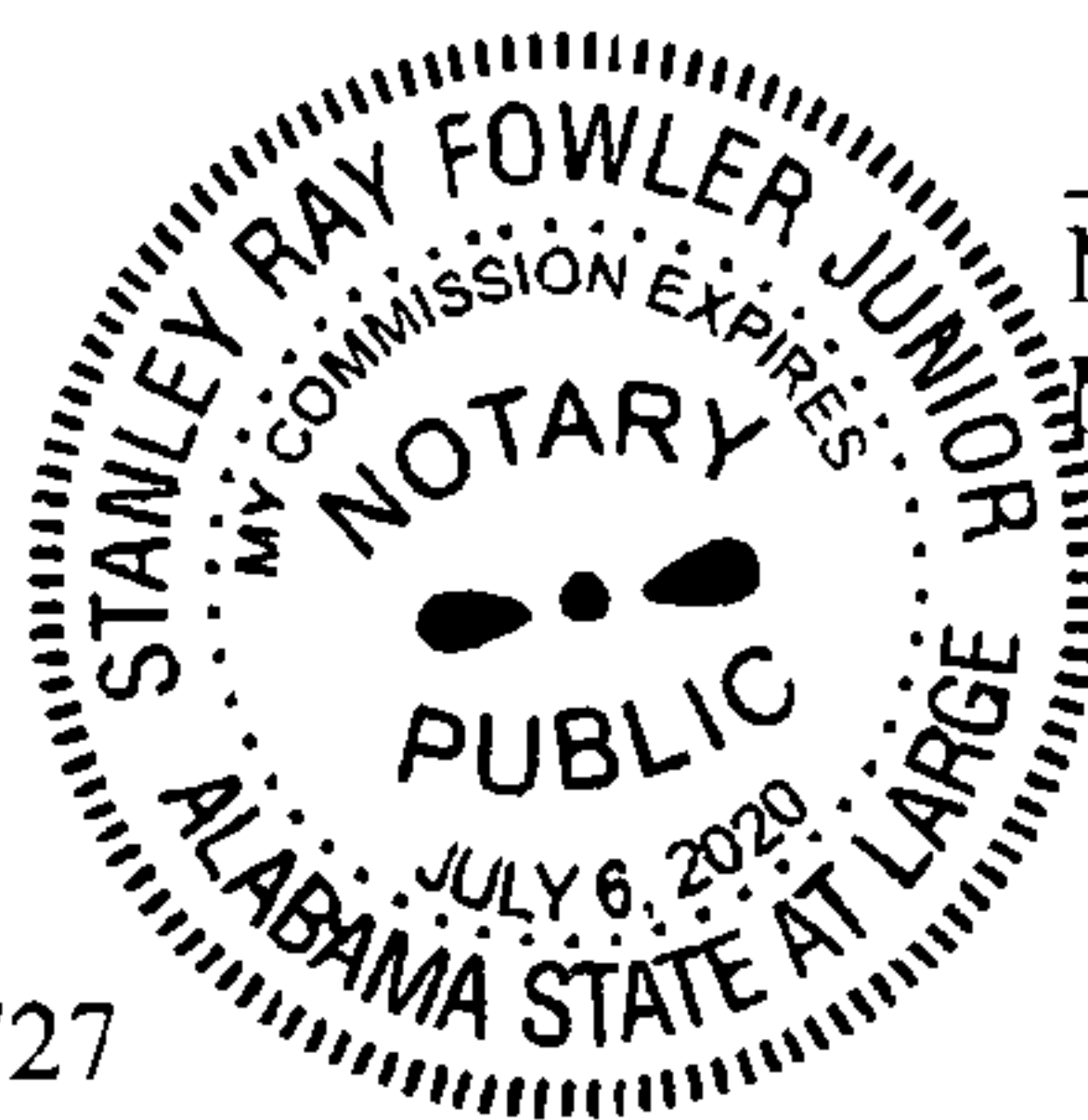

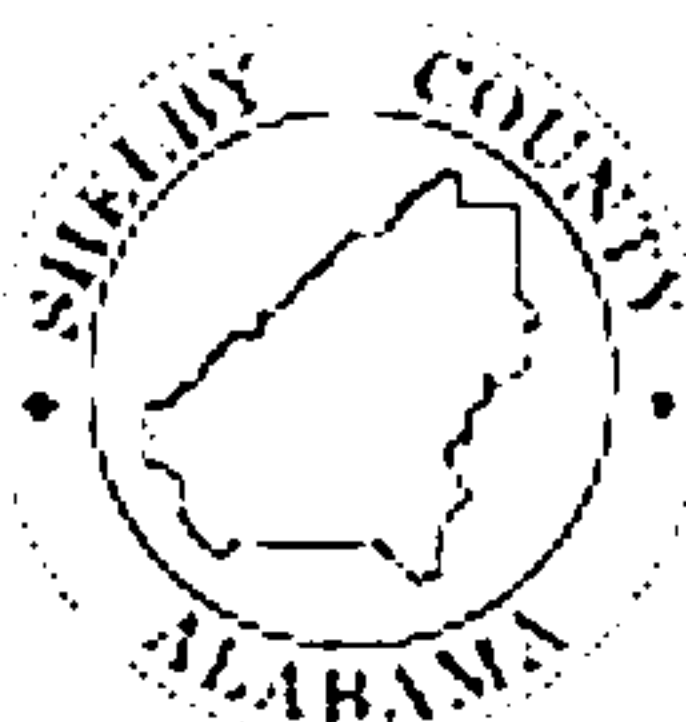
