## **CERTIFICATE OF FORMATION**

**OF**

**BLUE CHAIR, LLC**

The undersigned organizer, for the purpose of forming a limited liability company, hereby files this Certificate of Formation with the Office of Probate Judge of the county in which the initial registered office of the limited liability company will be located and affirms that the facts stated in this Certificate of Formation are true and correct.

### **SECTION 1. NAME OF COMPANY**

The name of the limited liability company is Blue Chair, LLC (the "Company").

### **SECTION 2. TYPE OF ENTITY**

The Company is a limited liability company formed under chapter 5A of title 10A of the *Code of Alabama* (1975), as amended (the "Law").

### **SECTION 3. PURPOSES AND POWERS**

The Company is formed for the purpose of carrying on any lawful activity. The Company shall have all of the power as set forth in Section 10A-5A-1.04 *Code of Alabama* (1975), as in effect from time to time, and such other powers as may be granted to limited liability companies in the State of Alabama or such other jurisdictions as the Company may be doing business from time to time.

### **SECTION 4. INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

The location and mailing address of the initial registered office of the Company is 1001 Regency Way, Birmingham, Alabama 35242. The name of the initial registered agent for service of process at the foregoing address is David McCullum.

The Company shall not be dissolved by the cessation of membership of one or more of its members and shall otherwise be dissolved only as provided in the Company's Limited Liability Company Agreement or by the Law.

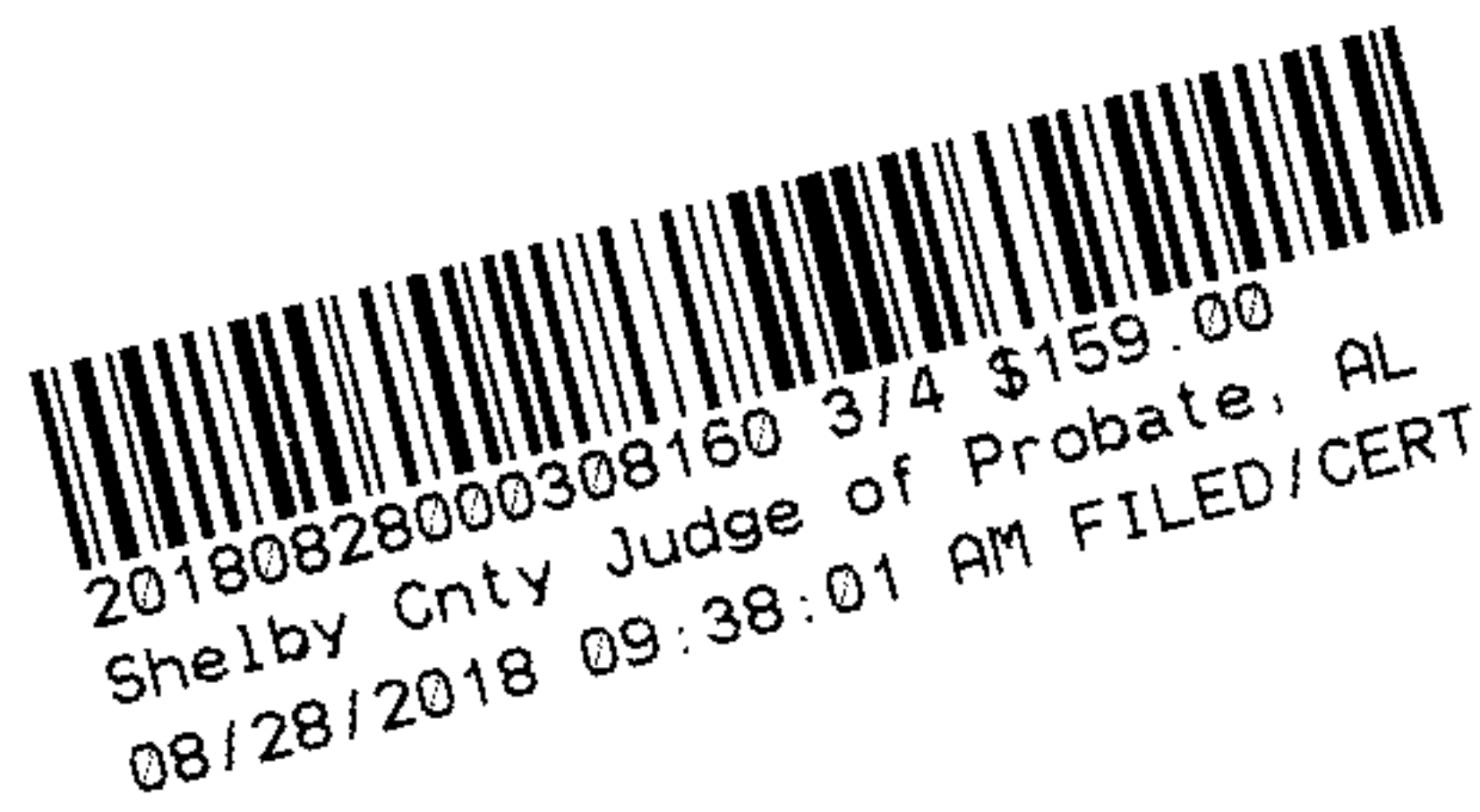
