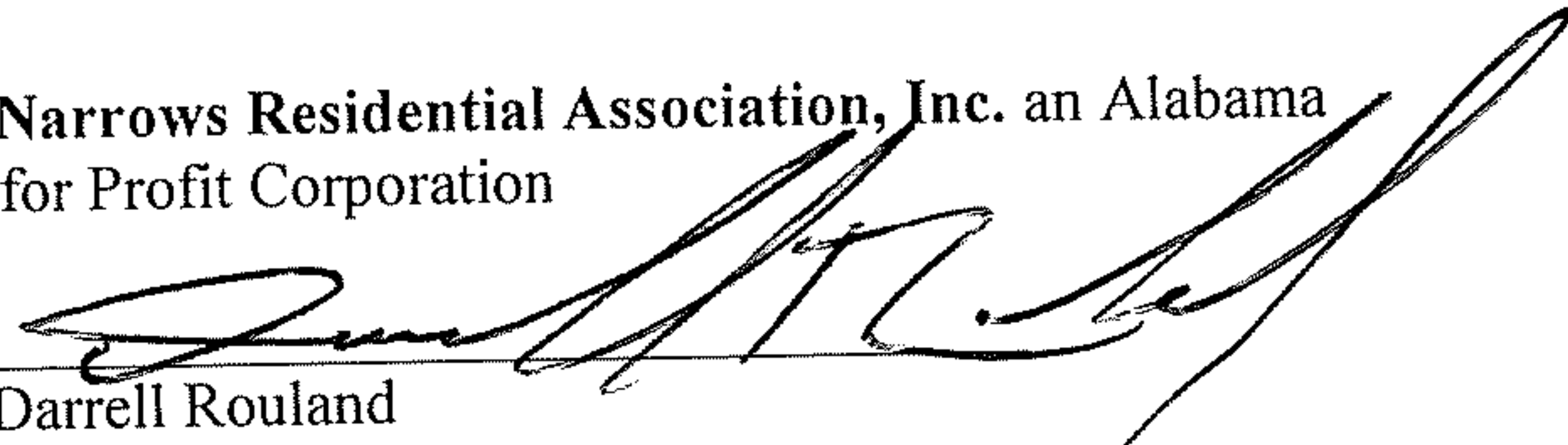
The Association claims a lien upon property owned by Mark & Renae Frederick situated in Shelby County, Alabama described as follows:

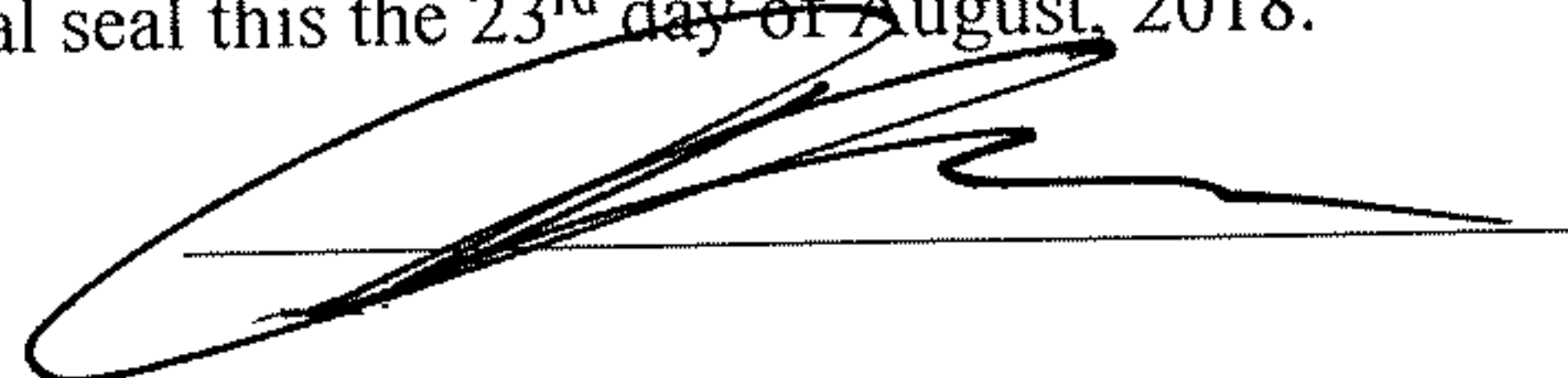

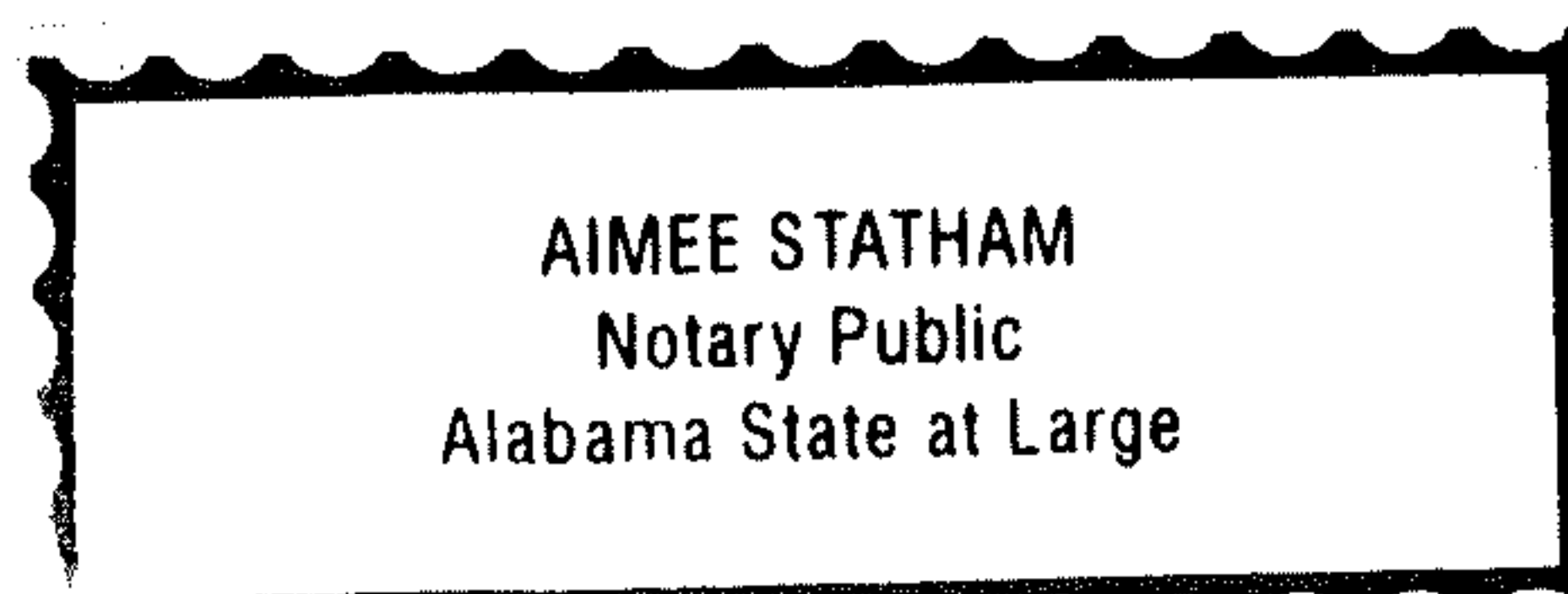
