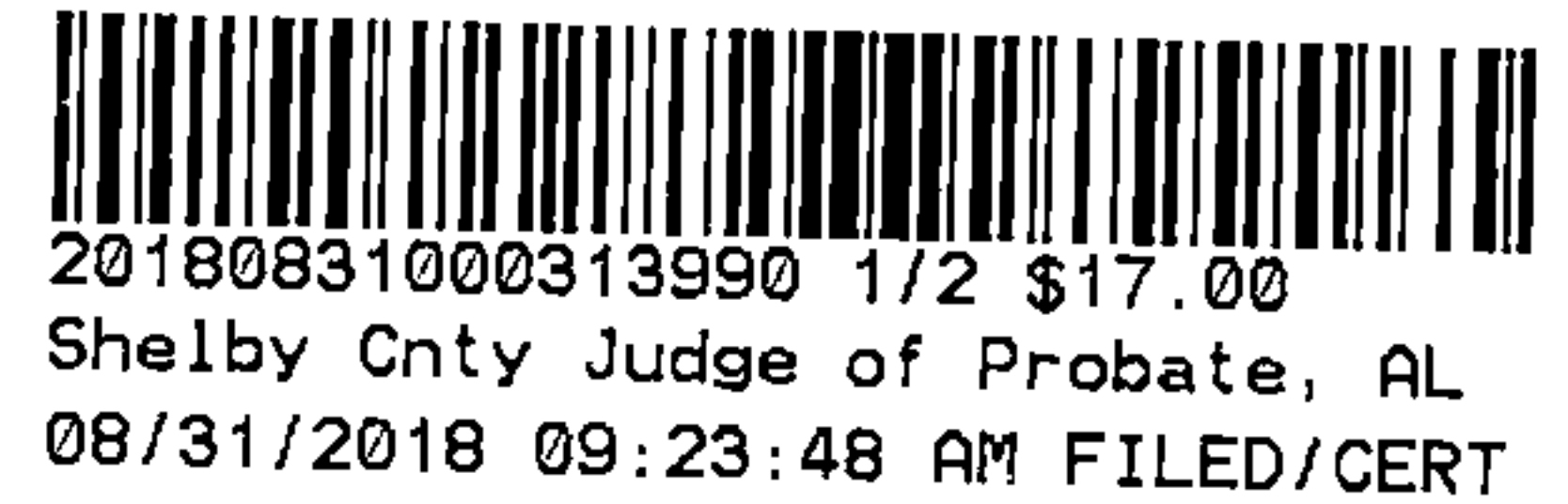

3. The administrative and/or managerial powers of the trustee are:
Pursuant to the powers granted to the trustees in the Trustee Powers Article Nine of our Trust: Our Trustees under our Trust Agreement are authorized to acquire, sell, convey, encumber, lease, borrow, manage and otherwise deal with interests in real and personal property in our Trust name. Our Trustees shall have full banking arrangements, including, but not limited to, safe deposit boxes, savings, checking and CD accounts. All powers of our Trustees are fully set forth in the Trustee Powers Article Nine of our Trust Agreement.
4. The Trust is revocable.
5. The following trustees have the authority to sign documents and instruments: **ROBERT STEPHENS GRANT**, as Trustee.
6. Trust Property should be titled as follows: **ROBERT STEPHENS GRANT as Trustee of the FLORENCE G. GRANT AMENDED AND RESTATED TRUST** dated January 11, 2016.
7. To the best of the undersigned's knowledge, the trust has not been revoked, modified, or amended in any manner that would cause the representations and statements contained herein to be incorrect.

8. No person or entity paying money to or delivering property to my Trustee shall be required to see its application. All persons relying on this document regarding the Co-Trustees and their powers over trust property shall be held harmless for any resulting loss or liability from such reliance. A Copy of this Certificate of Trust shall be just as valid as the original.

The undersigned Trustees certify that the statements in this Certificate of Trust are true and correct and that it is executed on this the 14th day of August, 2018.

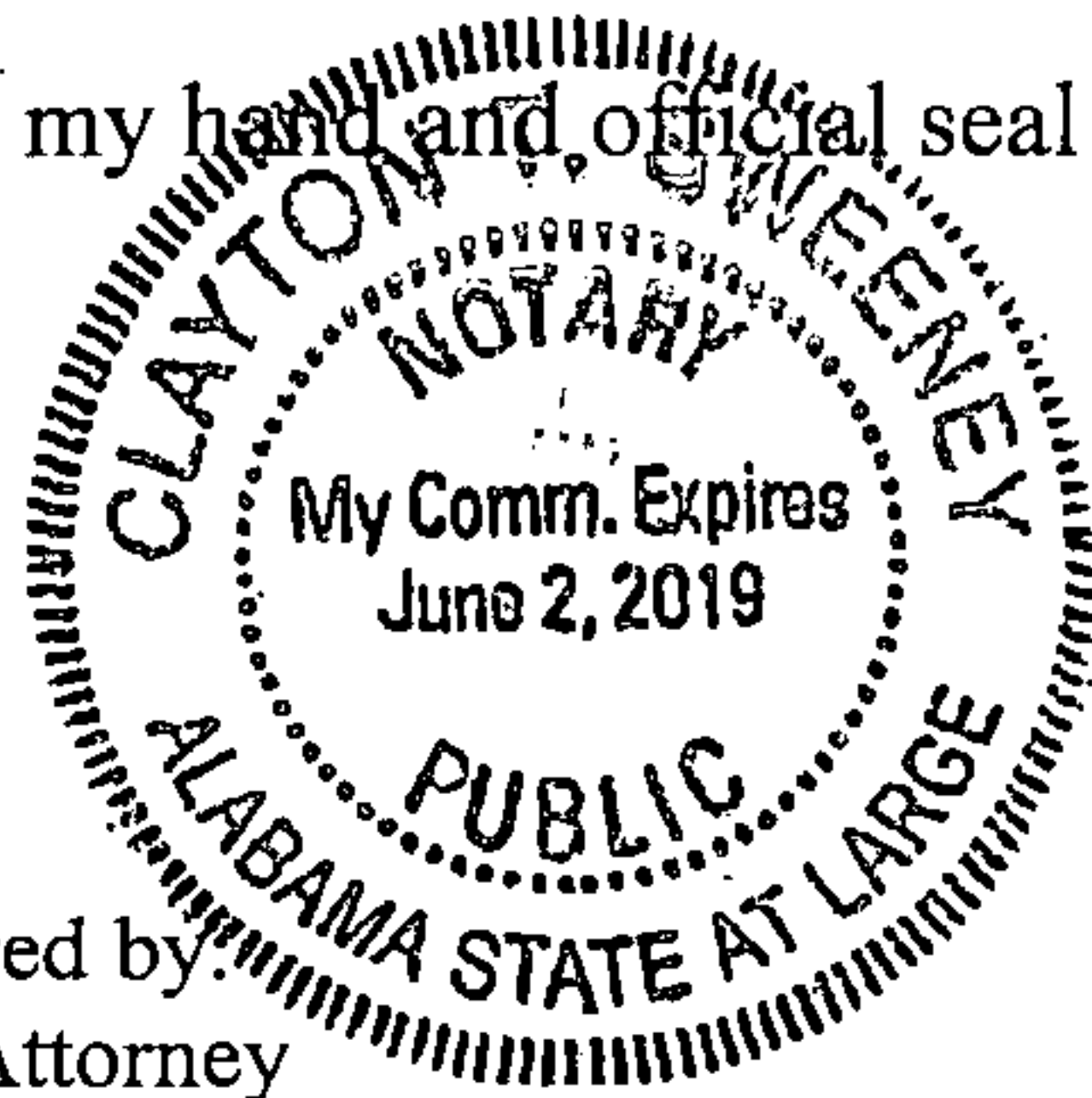


