**INSTRUCTIONS:** Mail one (1) signed original and two (2) copies of this completed form and the appropriate filing fees to the Office of the Judge of Probate in the county where the limited liability company's (LLC) registered office is/will be located. Contact the Judge of Probate's Office to determine the county filing fees. **Make a separate check or money order payable to the Secretary of State for the state filing fee of \$100.00** for standard filing (based on date of receipt and volume) **or \$200.00 for expedited service** (processed within twenty four (24) hours after date of receipt from the County Probate Office) and the Judge of Probate's Office will transmit the fee along with a certified copy of the Certificate to the Office of the Secretary of State within 10 days after the Certificate is filed. Your notification of filing was provided by the Probate Judge's Office via a stamped copy which is evidence of existence (if it is certified by the Probate Office) according to 10A-1-4.04(c) and the Secretary of State's Office does not send out a copy. You may pay the Secretary of State fees by credit card if the county you are filing in will accept that method of payment. Your entity will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored.

# OPERATING AGREEMENT

OF

## VEGA-GARCIA PAINTING, LLC

**THIS OPERATING AGREEMENT** (this "Agreement") is made and entered into the record by the person executing this operating agreement as the Organizer and sole Member of **VEGA-GARCIA PAINTING, LLC** ("Company"), a limited liability company organized pursuant to Title 10, Chapter 12 of the Code of Alabama (1975), as amended (the "Act"). This Agreement shall relate back to and remain effective as of the date of filing of the Certificate of Formation with the probate judge in the county where the initial registered office is located.

### RECITALS

Jorge Ivan Vega-Garcia: Shall provide all capital contributions and shall own a 100% ownership interest in the Company, which includes the 100% share of all profits earned by the company; and he shall be listed as its organizer and sole member.

### ARTICLE I

#### FORMATION

1. **Organization.** The initial Member and organizer of VEGA-GARCIA PAINTING, LLC is Jorge Ivan Vega-Garcia.

2. **Name.** The name of the Company is **VEGA-GARCIA PAINTING, LLC**, and all business of the Company shall be conducted under that name, but in any case, only to the extent permitted by applicable law.

3. **Term.** The term of duration of the Company commenced with the original filing of the Certificate of Formation and shall continue until the date upon which dissolution occurs pursuant to the terms of this Agreement or pursuant to the laws of the State of Alabama.

5. **Registered Agent and Office.** The registered agent for the service of process and the registered office shall be that person and location reflected in the Certificate of Formation as filed with the probate judge in the county where the initial registered office is located. The Member(s) may, from time to time, change the registered agent or office through appropriate filings with the probate judge of the county where the initial registered office is located. In the event the registered agent ceases to act as such for any reason or the registered office shall change, the Member(s) shall promptly designate a replacement registered agent or file a notice of change of address as the case may be. If the Member(s) shall fail to designate a replacement registered agent or change of address of the registered office, any Member may designate a replacement registered agent or file a notice of change of address.

6. **Principal Office.** The principal office (the "Principal Office") of the Company shall have a mailing address at: 101 Greenpark South, Pelham, AL 35124.

## ARTICLE II

### NATURE OF BUSINESS

The Company has been formed to acquire, hold, sell, and/or manage or lease real property and to engage in construction, painting, remodeling, and/or to engage in any other lawful act or activity for which limited liability companies may be organized pursuant to §10-12-4 of the Act.

## ARTICLE III

### ACCOUNTING AND RECORDS

The Company shall maintain its books and records at the Principal Office of the Company and each Member shall have access thereto. The taxable year of the Company shall be determined in accordance with the applicable provisions of the Internal Revenue Code of 1986, as amended (the "Code"), and the books of the Company shall be kept consistently therewith. The Company will cause to be prepared tax returns in a timely manner, furnishing copies to any member.
