The Trust also provides that trust assets may be used as collateral for a loan incurred by the Grantor, and the Trustee is duly authorized under the Trust document and applicable law to pledge or encumber the trust assets in connection with such a loan.
- 10. The Gale C. McManus Management Trust has not been revoked, modified or amended in any way that would cause the representations in this Certification of Trust to be incorrect.
