CERTIFICATION OF TRUST FOR THE

The Trust also provides that trust assets may be used as collateral for a loan incurred by the Grantor, and the Trustee is duly authorized under the Trust document and applicable law to pledge or encumber the trust assets in connection with such a loan.
10. The Gale C. McManus Management Trust has not been revoked, modified or amended in any way that would cause the representations in this Certification of Trust to be incorrect.
11. Reproductions of this original Certification of Trust with reproduced signatures shall be deemed to be original counterparts to this Certification.

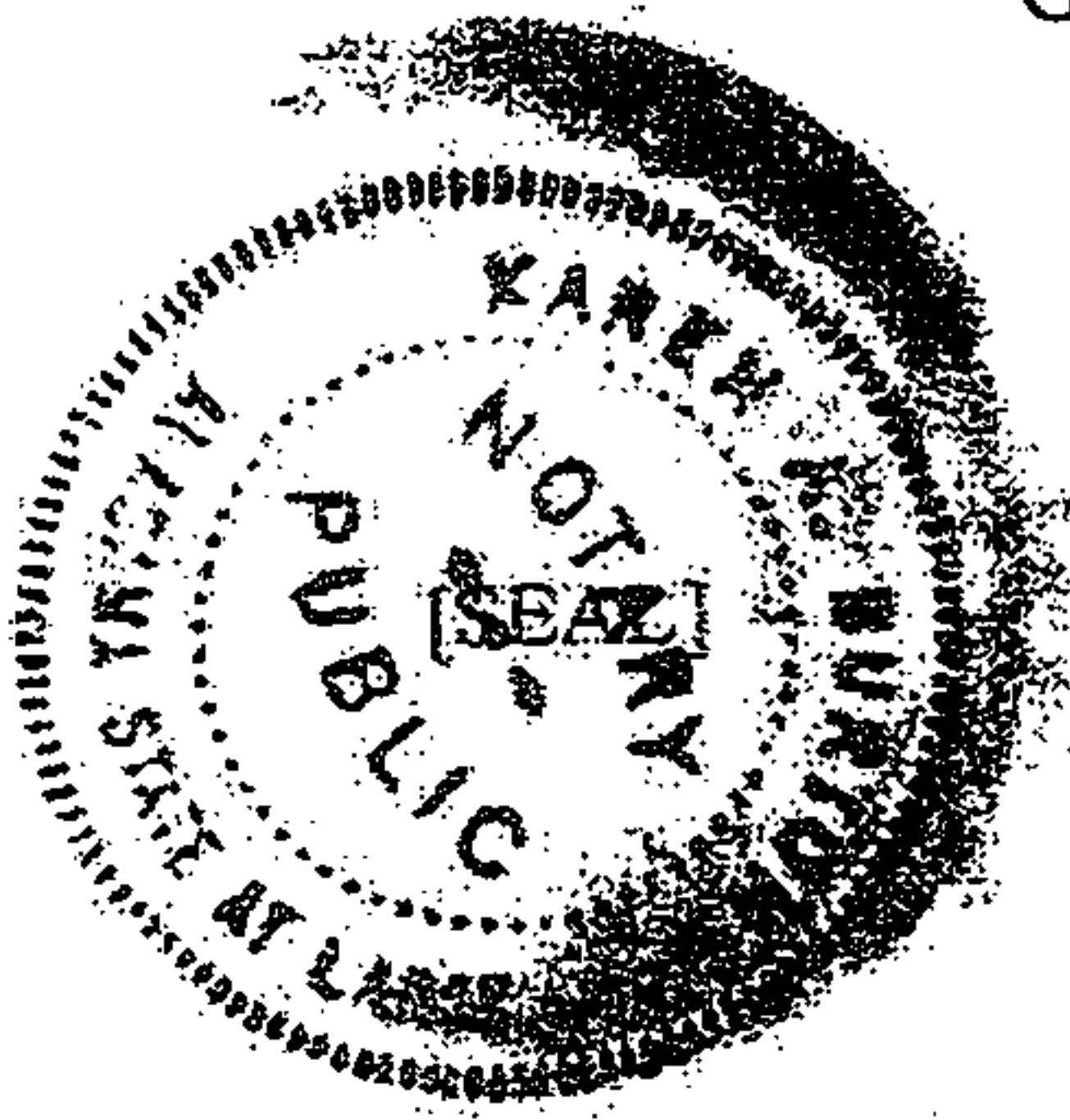
