
LIMITED POWER OF ATTORNEY



I, Scott James Reuter, presently residing at 1150 N. I hereby authorize my Attorney-in-Fact to act for me, in my name, and on my behalf for the following specific purposes:

- 1) To take all necessary steps to ensure the proper legal directives stated by mother in said will.
- 2) To perform all legal functions pertaining to the decedent and to myself as the first named Executor.
- To secure possession of any and all contents and personal property itmes in my mother's residence, as well as any and all bank accounts and cash, including the complete contents of any safety deposit boxes in her name.
- 4) I further direct and demand that my Attorney-in-Fact, Darla Pair, to keep updated records of all transactions and accounts for the future use and review of all such accounts by myself, Scott James Reuter.
- 5) To direct and complete the transfer of title to my mother's Toyota Avalon, to myself, Scott Reuter, and to arrange for the safe keeping of said vehicle.
- 6) To secure the residence of my mother and the real property attached to it, and to arrange for the fair sale of said property and transfer of the deed to said property to myself, Scott James Reuter.
- 7) To continue payment and keep current any home owners insurance policy on said real property until such time as it is sold.

- 8) To set up a separate bank account in my name to deposit and keep secure the proceeds from the sale of my mother's residence at 185 Wildberry Drive in Wsetover, Alabama 35147.
- 9) To request the bank to confirm the existence of the abovementioned account and the deposit of the real estate proceeds by informing myself of said activities.
- 10) The Attorney-in-Fact understands and agrees that she will not be compensated for acting on behalf for myself, the Principal, nor for performing her duties as Attorney-in-Fact. However, the Attorney-in-Fact may be, but is not required to be compensated and reimbursed for all necessary food, travel, and lodging expenses related to work as Attorney-in-Fact.

This Limited Power of Attorney shall be terminated upon the completion of her duties relating to all the directives in the Last Will and Testament of Pat H. Evett. It can also be terminated by the Principal, Scott James Reuter, through written revocation by the Principal and delivered through the U.S. postal service to the Attorney-in-Fact.

As Principal I hereby reserve all rights to personally perform any of the acts authorized by this Limited Power of Attoney for the execution of the subject Last Will and Testament. I understand and agree that I am hereby waiving my right to serve as Executor of my mother's will.
