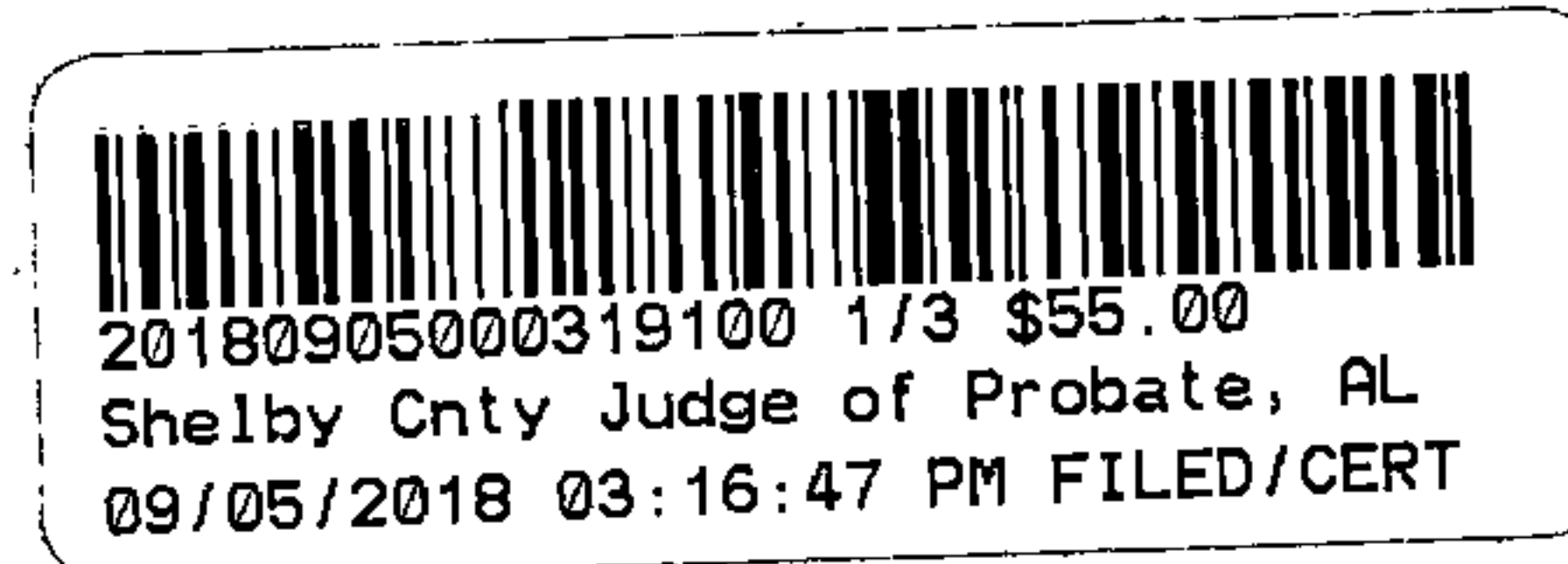

THAT IN CONSIDERATION OF One Hundred Thirty Five Thousand Four Hundred Eighteen Dollars and no/100 Dollars (\$135,418.00) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we/I Daniel K Davis and wife, Daisy Davis (herein referred to as grantor(s)) do grant, bargain, sell and convey unto Yanping Li and Deyi Chen (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

To Have And To Hold unto the said Grantees as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

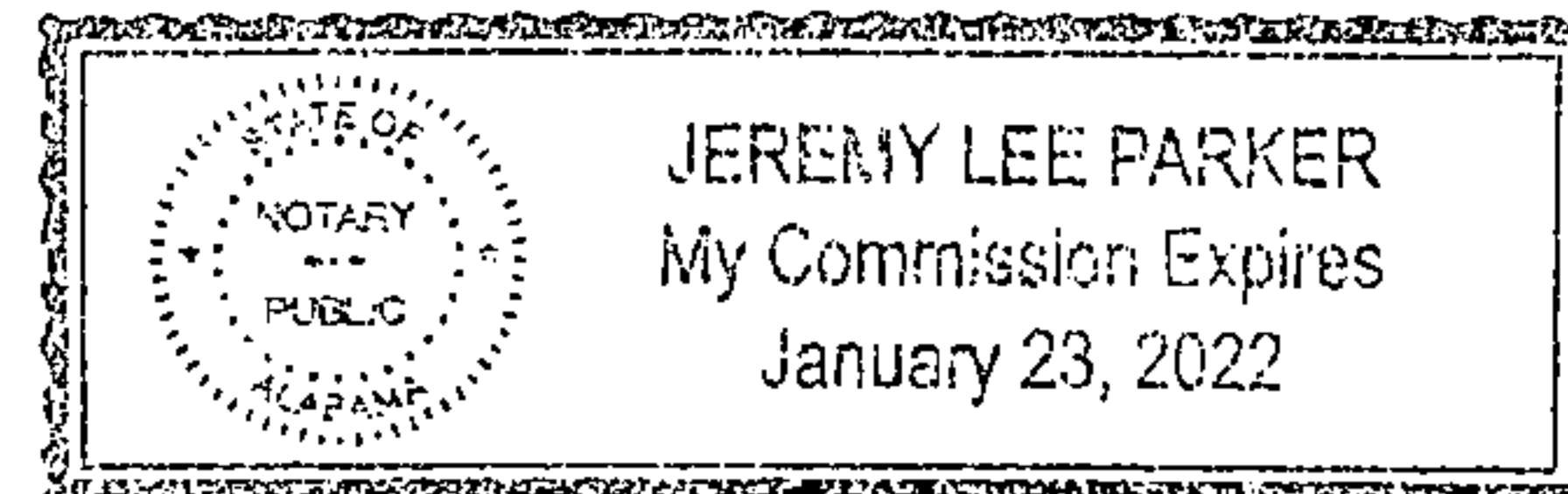
