

FORECLOSURE DEED

KNOWN ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore on, to-wit, June 24, 2010, Kory Wade Foster and Kaylin Foster, Husband and Wife, as Mortgagors, executed a Real Estate Mortgage on the property hereinafter described to Mortgage Electronic Registration Systems, Inc., as Nominee for DHI Mortgage Company, LTD which is recorded as Instrument Number 20100713000221690, in the Office of the Judge of Probate, Shelby County, Alabama on July 13, 2010 and subsequently assigned to Bank of America, N.A. and recorded as Instrument Number 20131106000438450 on November 6, 2013, and,

WHEREAS, in and by said Real Estate Mortgage, the said Mortgagee was authorized and empowered in case of default in the payment of the indebtedness thereby 'secured, according to the terms thereof, to sell said property before the Courthouse door of said County, giving notice of the time, place and terms of said sale in some newspaper published in said County, by publication once a week for three consecutive weeks prior to said sale at public outcry for cash, to the highest bidder, and said Real Estate Mortgage provided that in case of sale under the power and authority contained in same, the said Mortgagee, or any person conducting said sale for the Mortgagee, was authorized to execute title to the purchaser at said sale; and it was further provided in and by said Real Estate Mortgage that the said Mortgagee may bid at the sale and purchase said property if the highest bidder therefore; and,

WHEREAS, default was made in the payment of the indebtedness secured by said Real Estate Mortgage, and the said Mortgage did declare all of the indebtedness secured by said Real Estate Mortgage due and payable and said Real Estate Mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said Real Estate Mortgage in the Shelby County Reporter, a newspaper published in Shelby County, in its issues of August 15, 2018, August 22, 2018, and August 29, 2018; and,

WHEREAS, on September 4, 2018, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly and properly conducted, and the said Mortgagee did offer for sale and sell at public outcry in front of the door of the Courthouse of Shelby County, Alabama, the property hereinafter described; and,

WHEREAS, Walter Dean Crawford, was the Auctioneer who conducted said foreclosure sale and was the person conducting said sale for the said Mortgagee; and,
