

CERTIFICATE OF TRUST

1. Affiants are the Trustees of the SUDZ4 Trust and as such have the authority to execute this Certificate.
2. This Certificate of Trust relates to the SUDZ4 Trust dated this 22nd day of August, 2018.

Pursuant to the terms of the Trust Agreement, any person may rely upon this Certificate of Trust as evidence of the existence of said Trust, and is relieved of any obligation to verify that any transaction entered into by a Trustee or Successor Trustee thereunder is consistent with the terms and conditions of said Trust Agreement.
9. The proper manner for taking title to Trust property is:



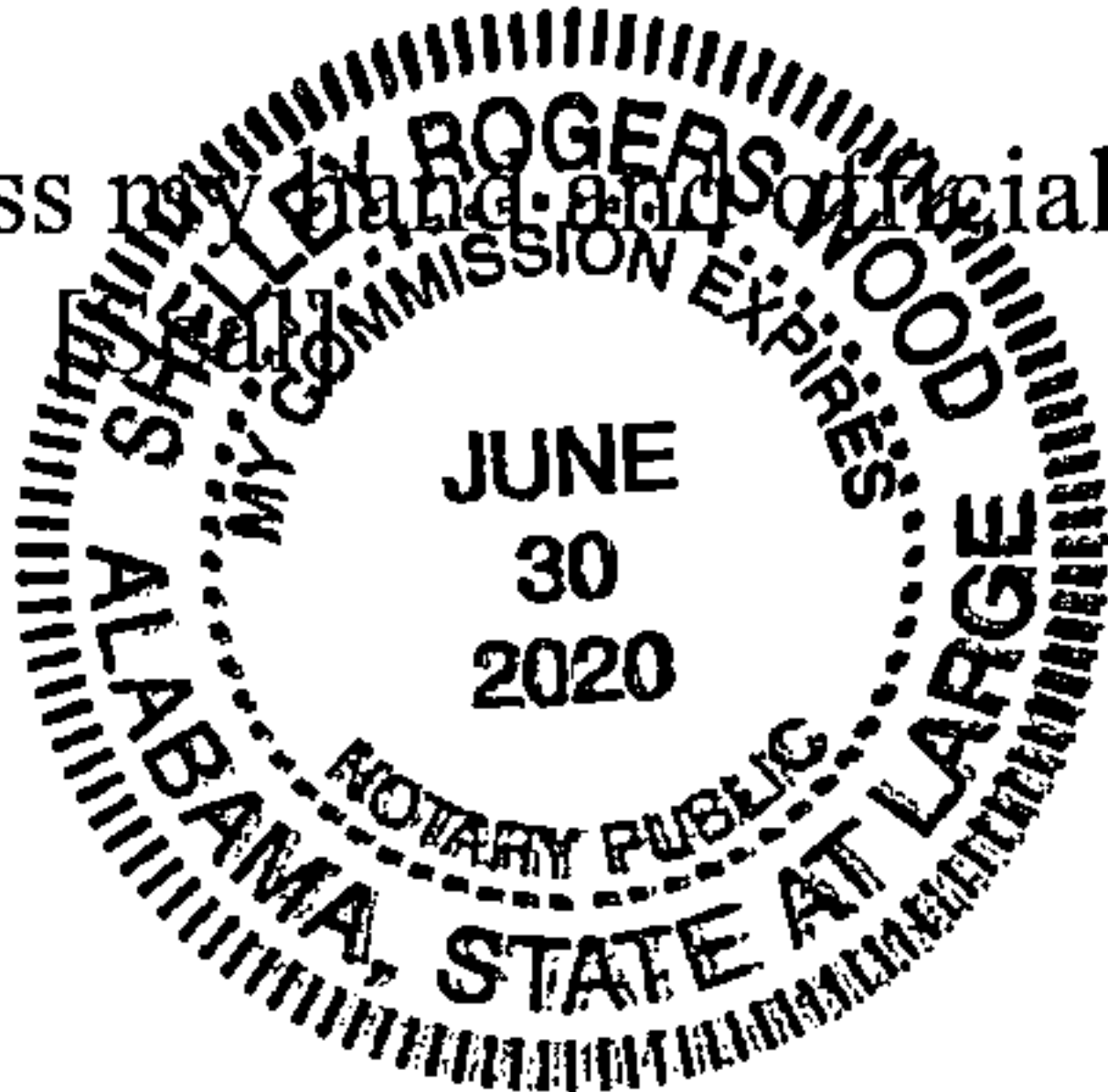
