Registered Office; Registered Agent

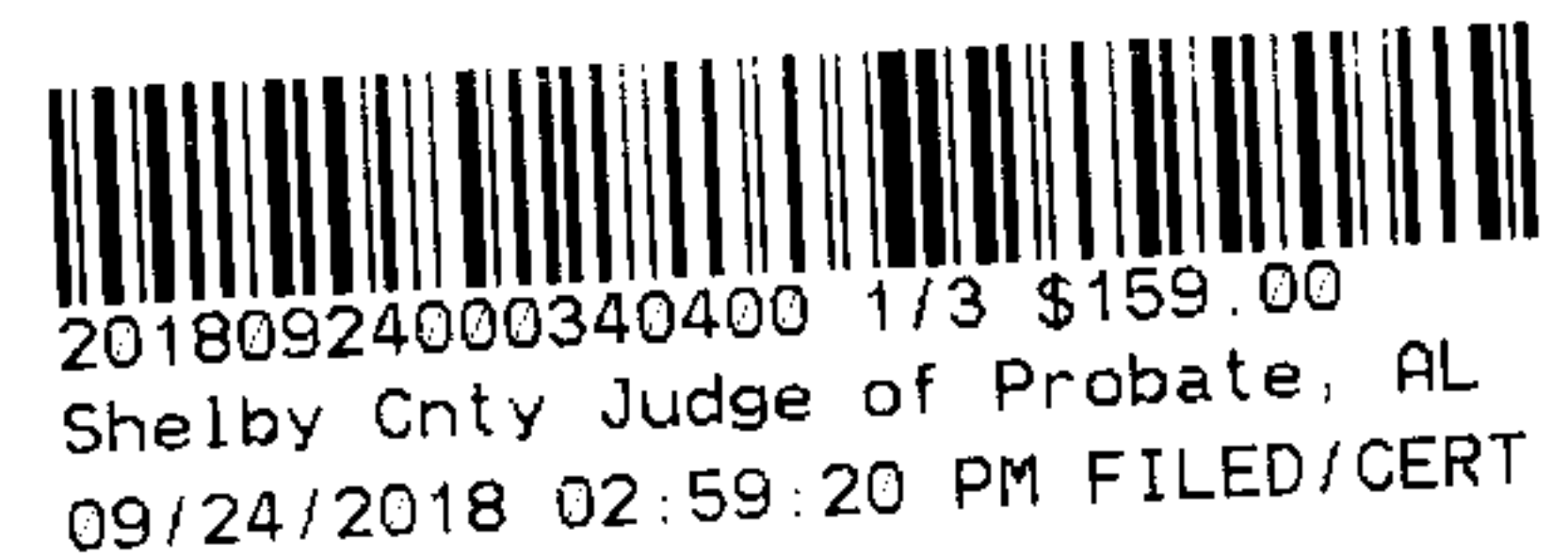
