For ad valorem tax purposes only, the address for the above described property is 4088 Old Cahaba Parkway, Helena, AL 35080.




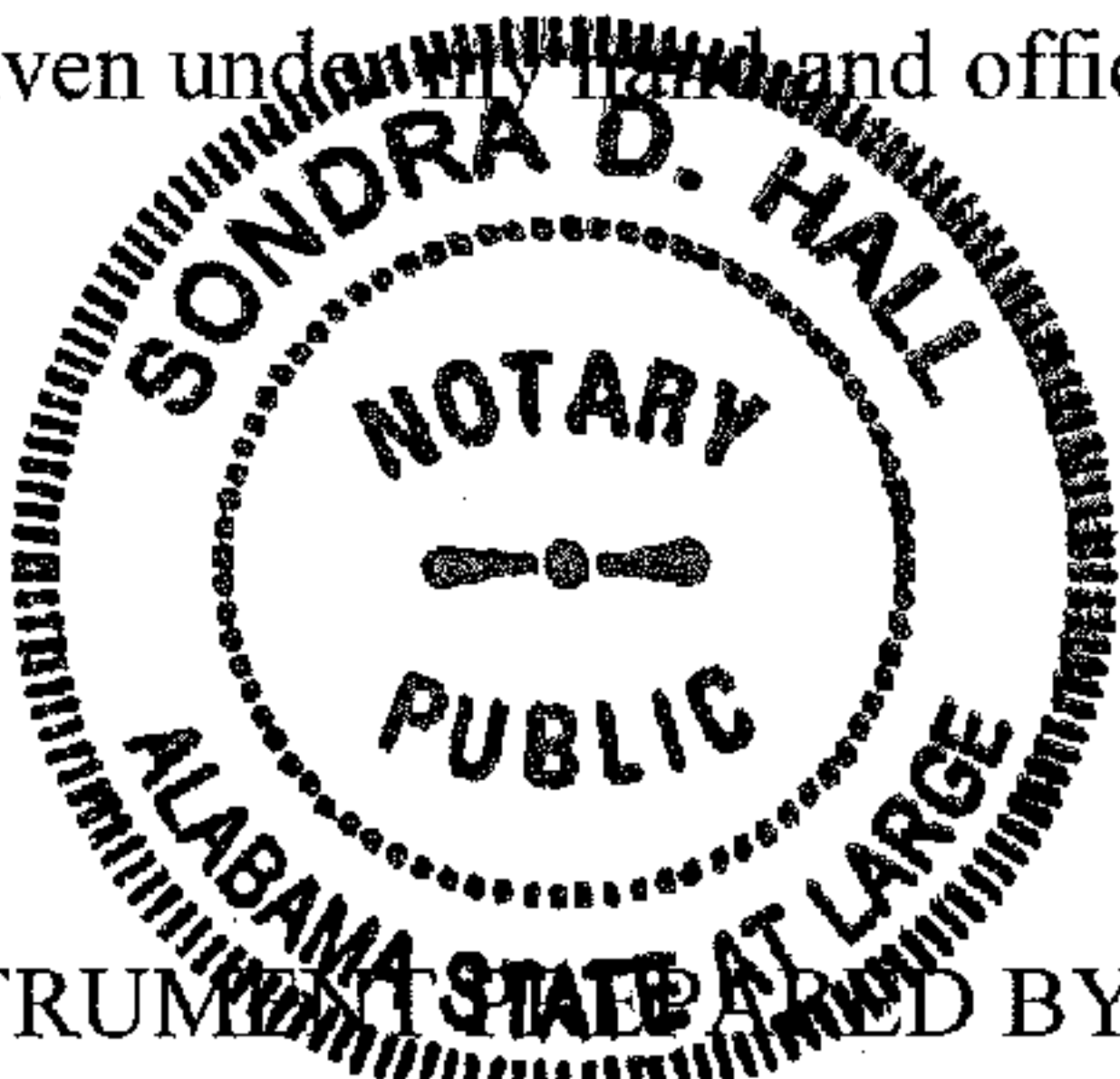


