This property constitutes no part of the homestead of the grantor, or of his/her spouse.

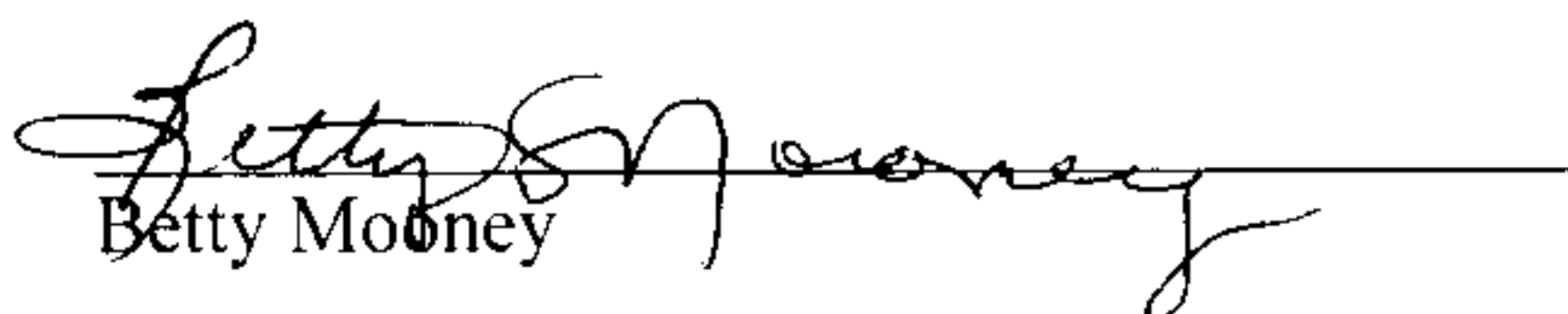
Subject to taxes for 2018 and subsequent years, easements, restrictions, rights of way and permits of record.

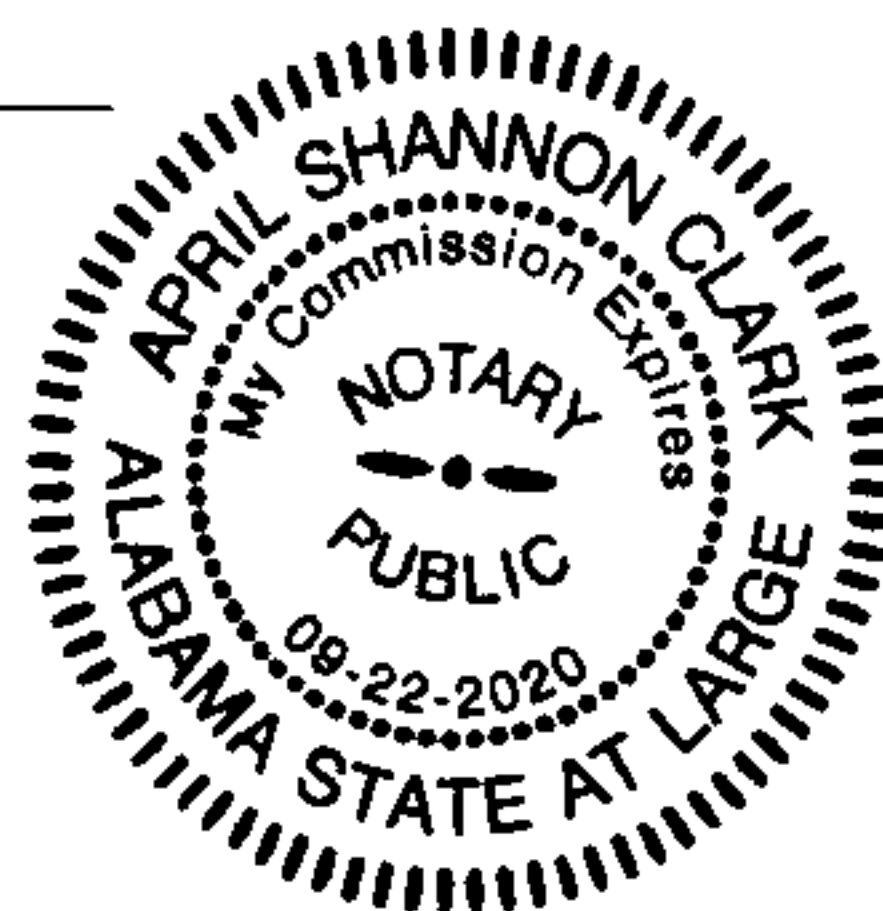
