(herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Jason L. Vandiver and Amy B. Vandiver
(herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in SHELBY County, Alabama, to-wit:

Lot 366, according to the Plat of The Village at Polo Crossings, Sector II, as recorded in Map Book 49, Page 3, of the Probate Office of Shelby County, Alabama.

Mineral and mining rights excepted. Subject to: current taxes, conditions, covenants, easements and restrictions of record.

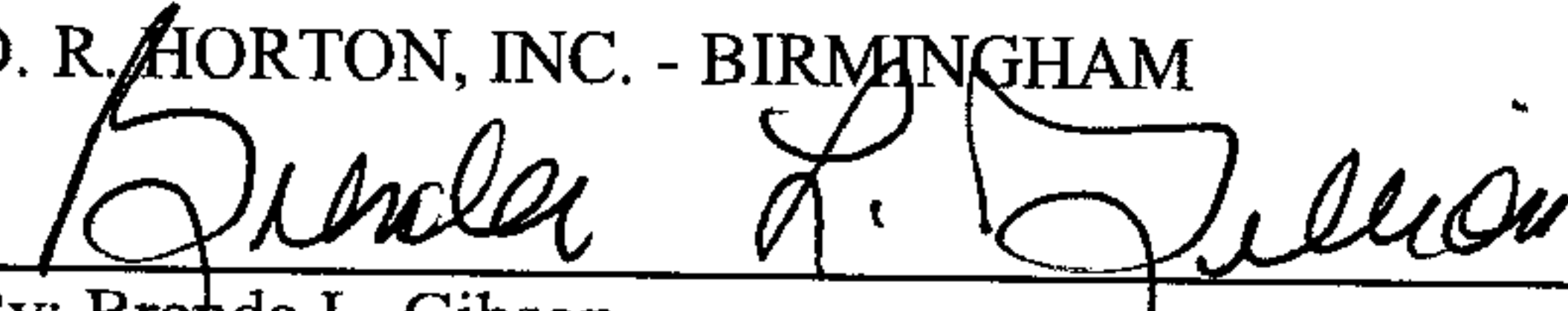

This covenant and agreement shall run with the land conveyed hereby as against Grantees, and all persons or entities holding under or through Grantees.

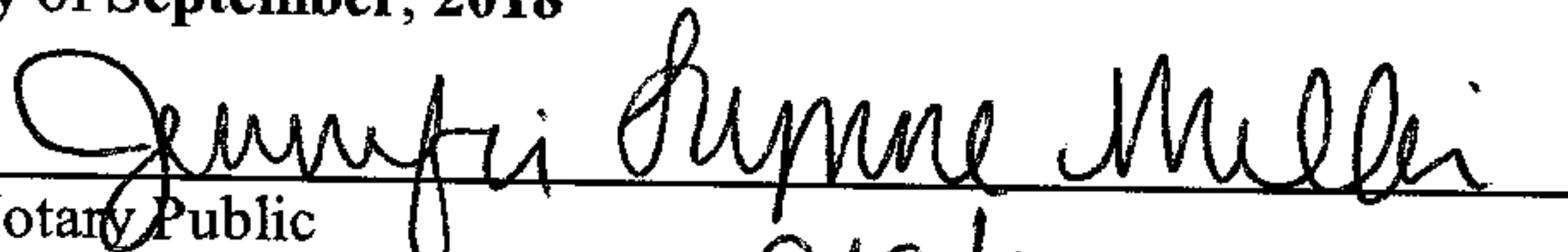

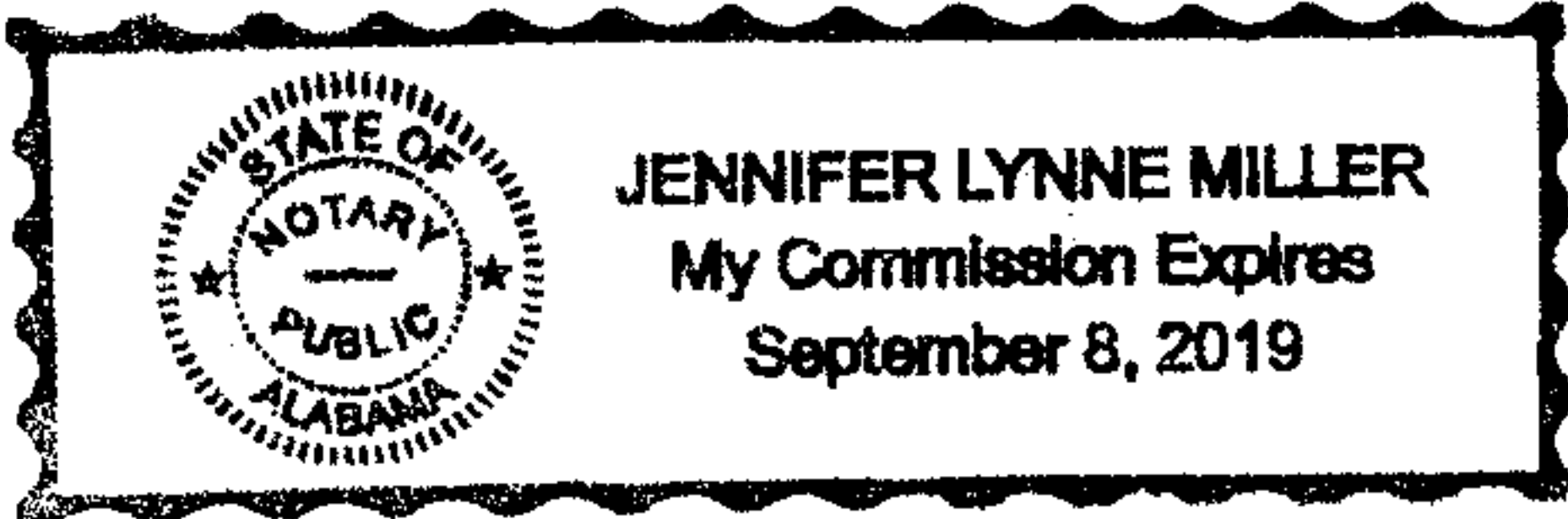
