(herein referred to as grantees) as joint tenants with right of survivorship, the following described real estate property situated in Shelby County, Alabama, the address of which is: 157 Canyon Trail, Pelham, AL 35124 to-wit:

Subject to: All easements, restrictions and rights of way of record.

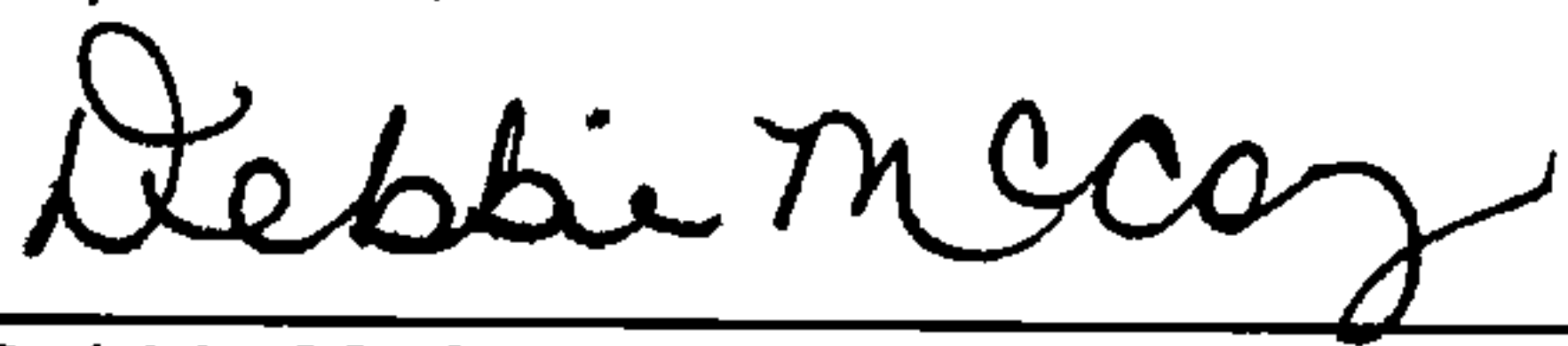
\$142,373.00 of the above mentioned purchase price was paid for from a mortgage loan which was closed simultaneously herewith.

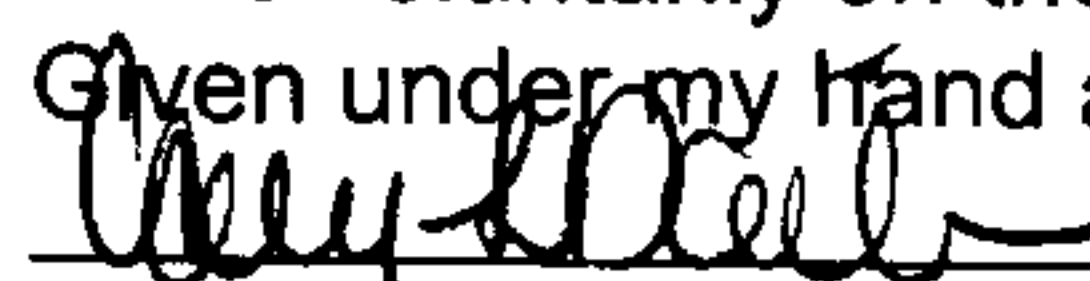
