
The undersigned Trustee hereby certifies the following:

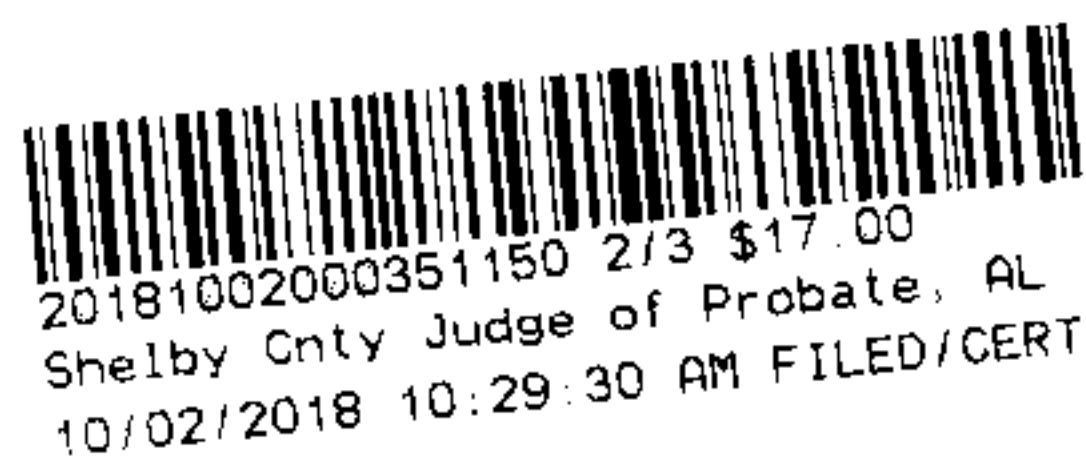
