MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That

WHEREAS, heretofore, on, to-wit: the 28th day of August, 2008, THOMAS P JOHNSON, a single person executed that certain mortgage on real property hereinafter described to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS INC AS NOMINEE FOR NEW SOUTH FEDERAL SAVINGS BANK, which said mortgage was recorded in the Office of the Judge of Probate in Shelby County, Alabama, on September 9, 2008, at Instrument Number 20080909000358220, Shelby County, Alabama Records, said Mortgage having subsequently been transferred and assigned to **PENNYMAC LOAN SERVICES, LLC**, by instrument recorded in at Instrument Number 20180807000281680, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, default was made in accordance with the loan terms, and PennyMac Loan Services, LLC did declare due all of the indebtedness secured by said mortgage, subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage by publication in the Shelby County Reporter, a newspaper of general circulation published in Shelby County, Alabama, in its issues of August 22, 2018, August 29, 2018, September 5, 2018, that the property would be sold on September 17, 2018; and

WHEREAS, on September 17, 2018, the day on which the foreclosure was due to be held under the terms of the said notice, between the legal hours of sale, said foreclosure was duly conducted, and PennyMac Loan Services, LLC did offer for sale and sell at public outcry in front of the Courthouse door in Shelby County, Alabama, the property hereinafter described; and





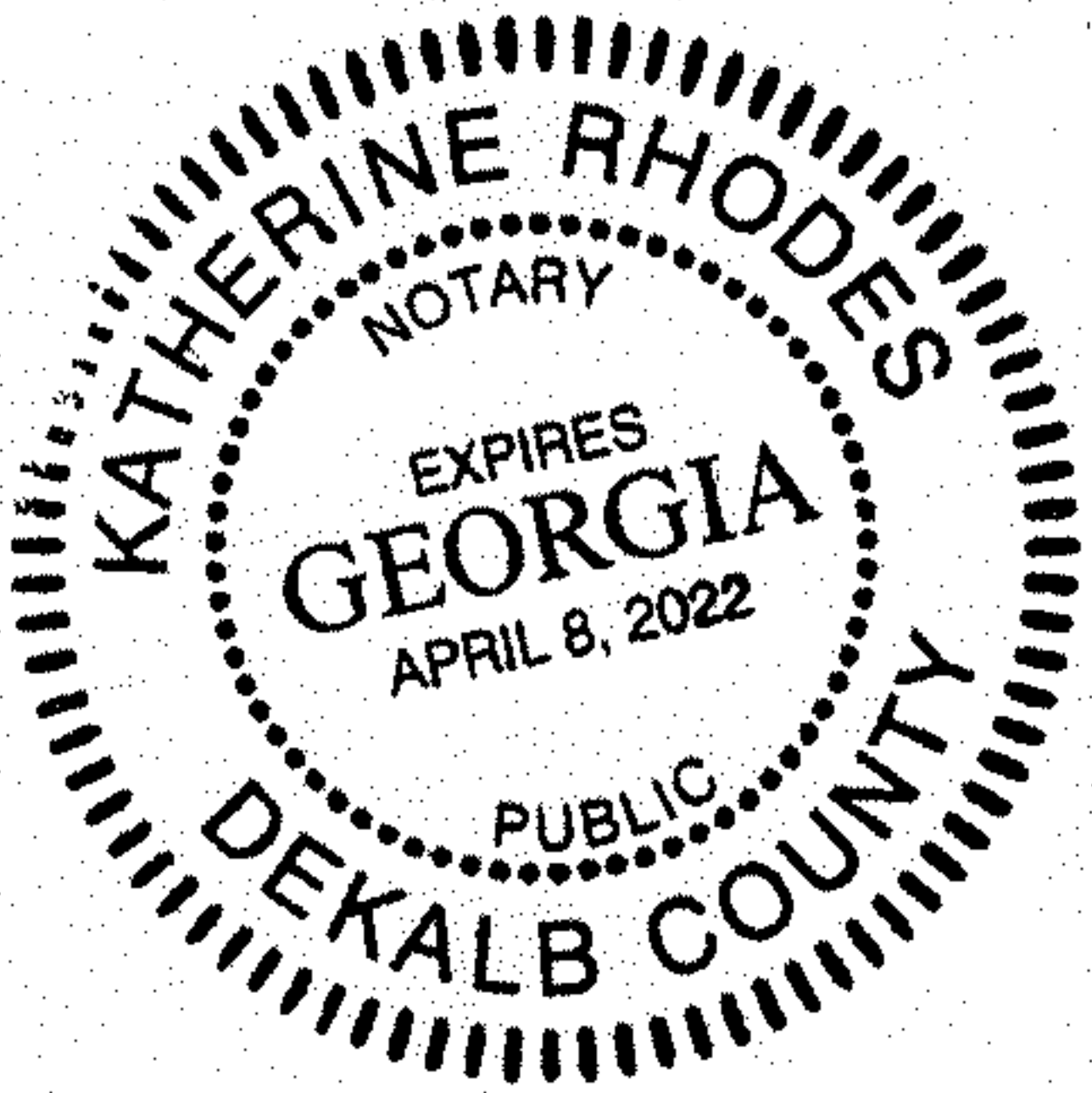
