

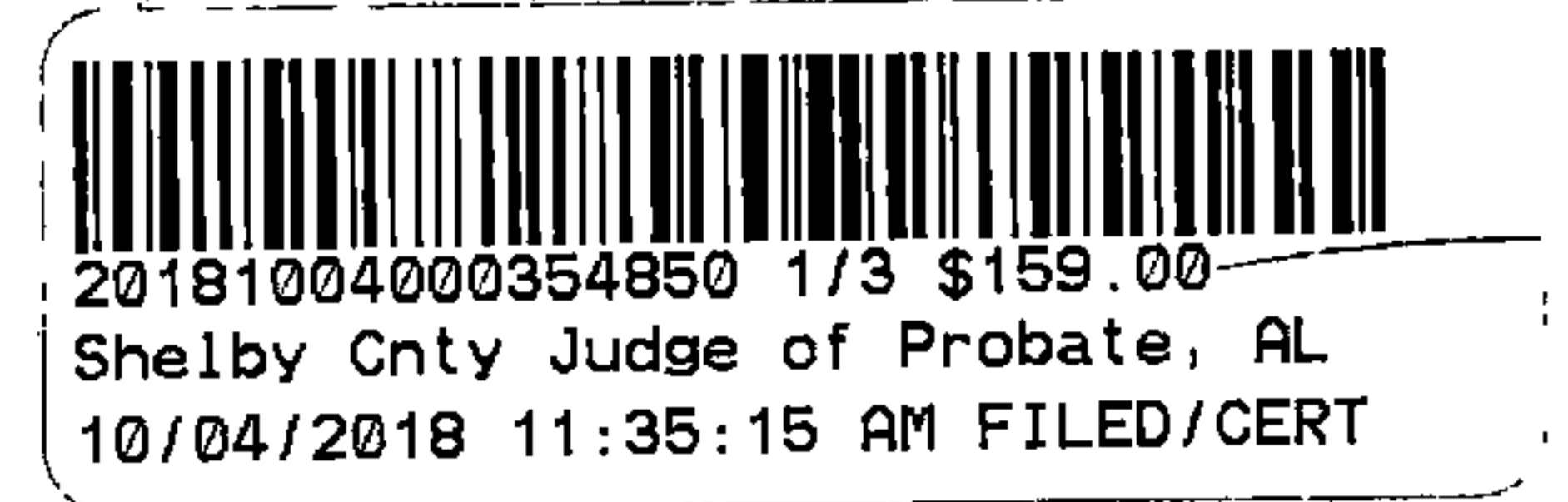

## CERTIFICATE OF FORMATION

An Alabama Limited Liability Company



Pursuant to the provisions of §10A-5A-1.01, et seq., Code of Alabama (1975) ("*the Alabama Limited Liability Company Law of 2014*") the undersigned hereby adopts the following Certificate of Formation.

### ARTICLE ONE

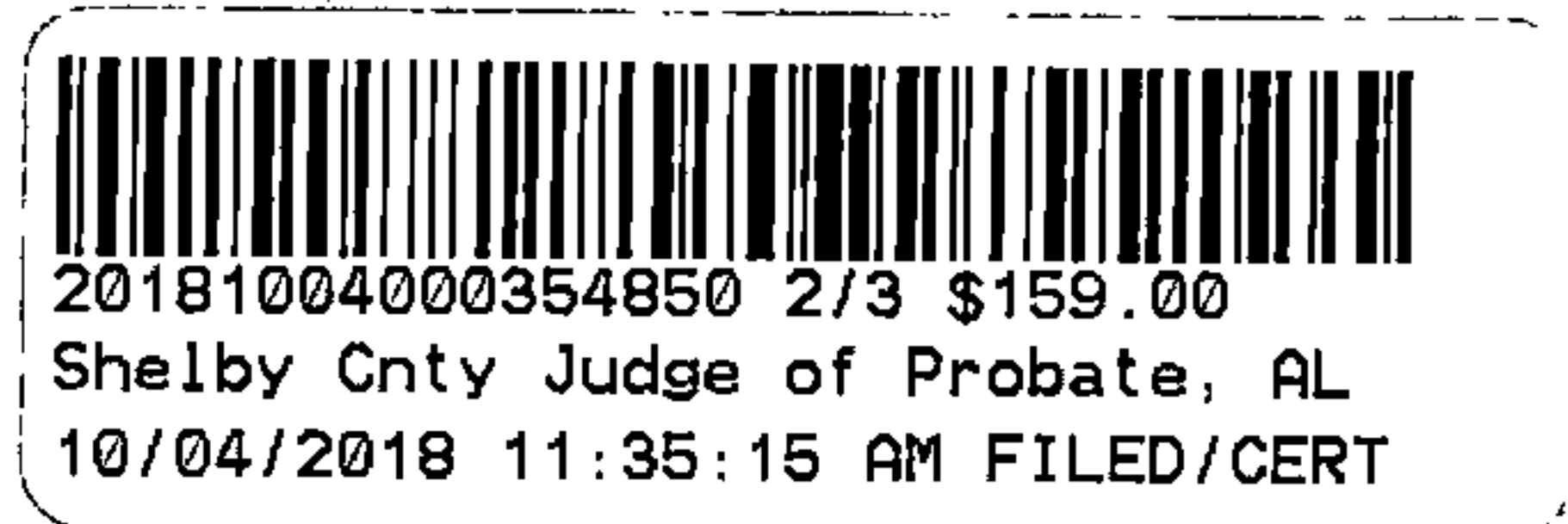
