ORDER FOR DEFAULT JUDGMENT

This action came on the motion of the Plaintiff for a Default Judgment pursuant to Rule 55(b)(2), Alabama Rules of Civil Procedure. The motion was filed after the Plaintiff made several attempts at service to the Defendant, including via Publication, and the Defendant failed to plead or otherwise defend the action.

The Plaintiff appeared in this Court on May 23, 2018 while the Defendant was not present. The Defendant's default has been duly entered and the Defendant has not


taken any proceedings since such default was entered.

Based upon the above, it is **ORDERED** and **ADJUDGED** that:

- 1. The Plaintiff's Motion for Default Judgment is GRANTED.
- 2. The Defendant shall to pay the Plaintiff \$50,666.75 immediately.
- 3. A writ of arrest shall be issued for the Defendant.
- 4. A lien shall be placed on any property, bank accounts, or other tangible items owned by the Defendant until his debt is paid to the Plaintiff.
- 5. The Plaintiff, additionally, shall be awarded attorney's fees in the amount of \$7,500.
