
7. The Company shall be managed by its sole member.

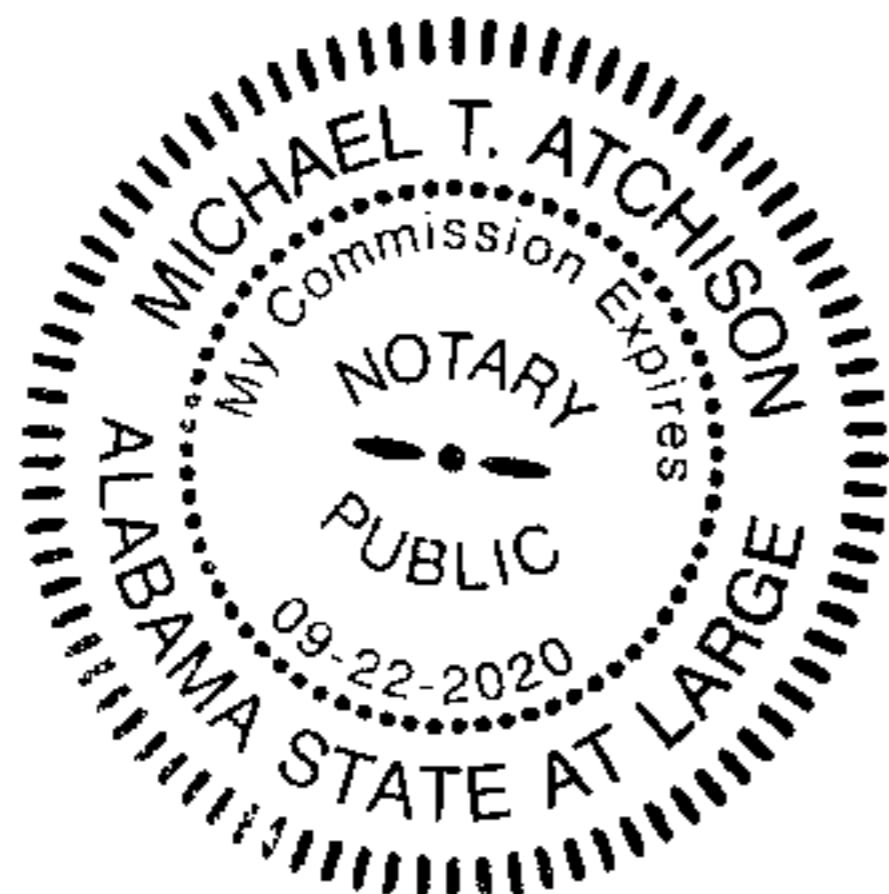



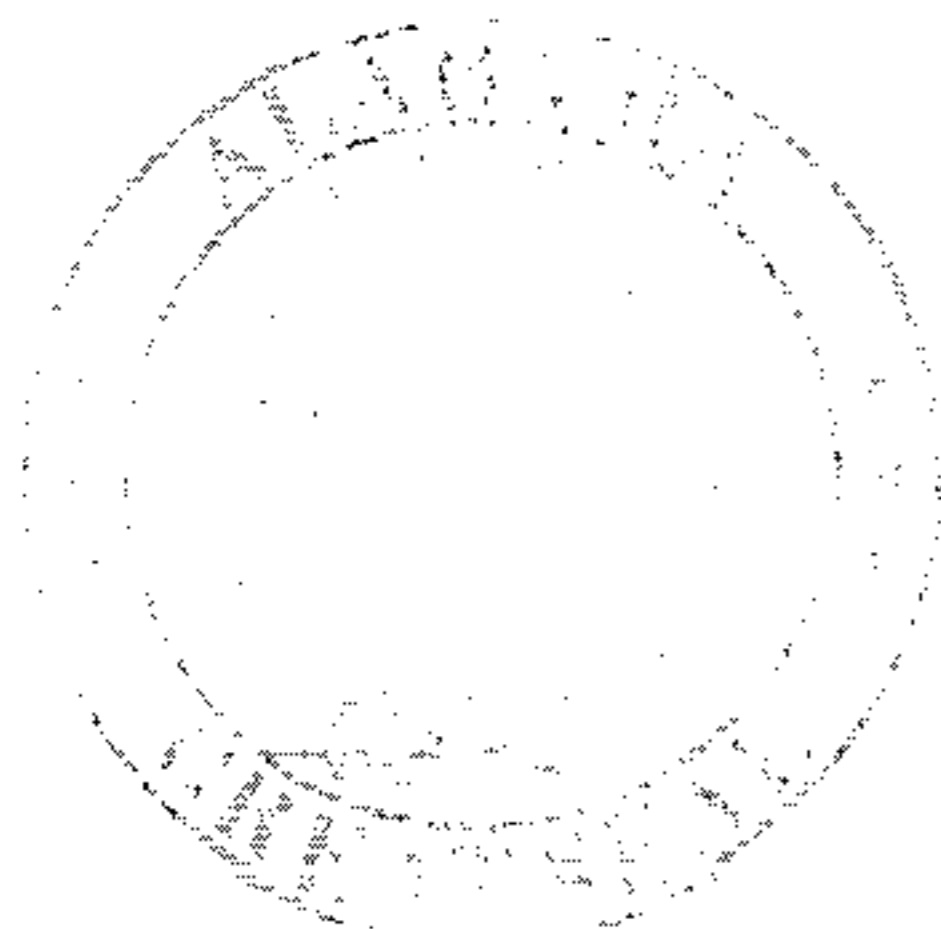
