

#### FORECLOSURE DEED

#### KNOWN ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore on, to-wit, May 6, 2011, Precious Hamilton, an Unmarried Woman, as Mortgagor, executed a Real Estate Mortgage on the property hereinafter described to Mortgage Electronic Registration Systems, Inc., as DHI Mortgage Company, LTD which is recorded as Instrument Number 20110518000148950, in the Office of the Judge of Probate, Shelby County, Alabama on May 18, 2011 and subsequently assigned to Bank of America, N.A., Successor by Merger to BAC Home Loans Servicing, LP f/k/a CountryWide Home Loans Servicing, LP and recorded as Instrument Number 20111104000331960 on November 4, 2011, and,

WHEREAS, on September 24, 2018, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly and properly conducted, and the said Mortgagee did offer for sale and sell at public outcry in front of the door of the Courthouse of Shelby County, Alabama, the property hereinafter described; and,


WHEREAS, Aaron Warner, was the Auctioneer who conducted said foreclosure sale and was the person conducting said sale for the said Mortgagee; and,
