KNOW ALL MEN BY THESE PRESENTS, That in consideration **SEVENTY EIGHT THOUSAND FIFTY AND NO/00 DOLLARS (\$78,050.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **John P. Perkins, III and wife John Etta Perkins** (herein referred to as **Grantor**) grant, bargain, sell and convey unto **John P. Perkins, John Etta Perkins, Alisa Renee Perkins and John Nolan Wise** (herein referred to as **Grantees**), the following described real estate, situated in: **SHELBY County, Alabama**, to-wit:

SUBJECT TO:

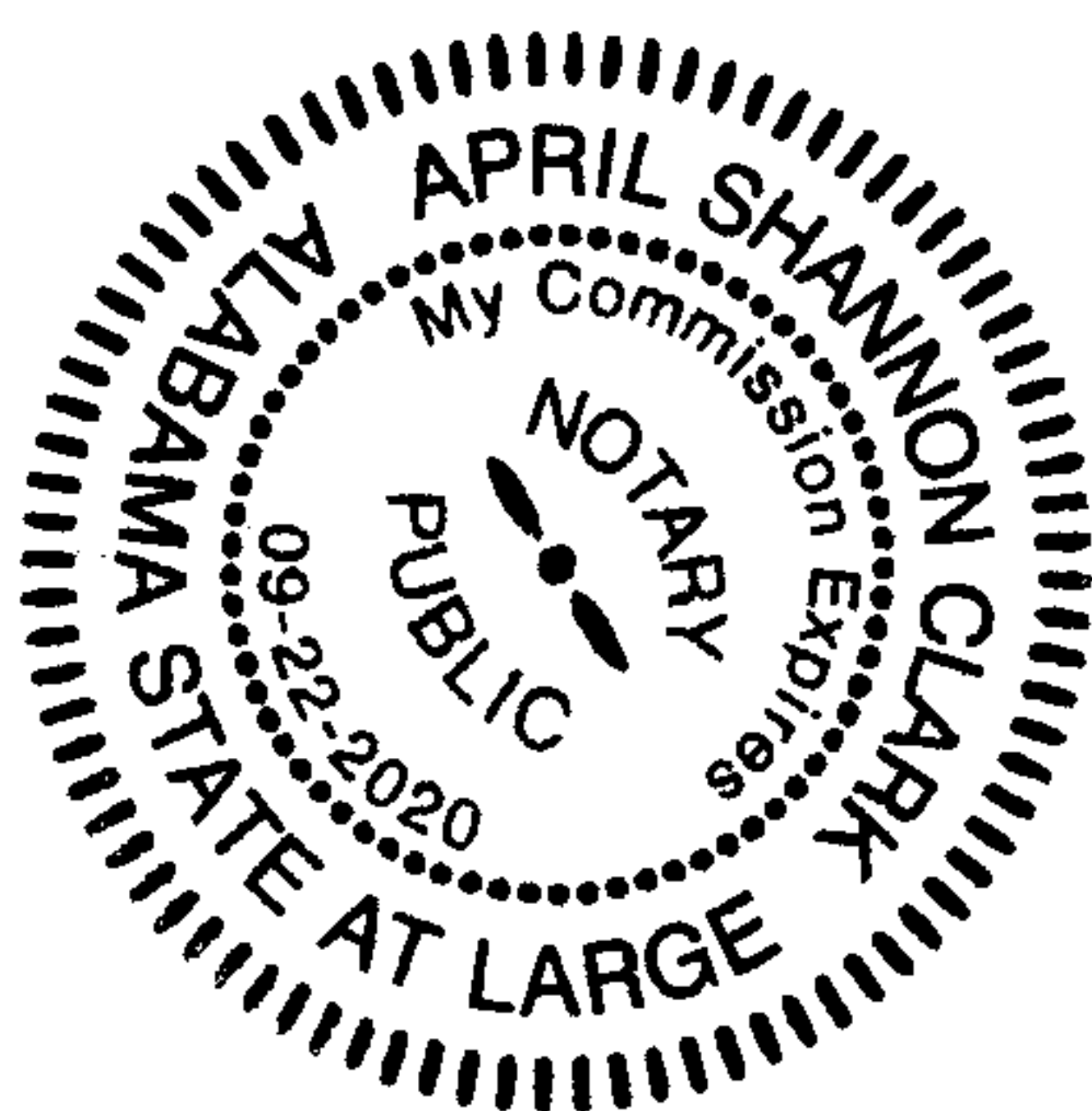



