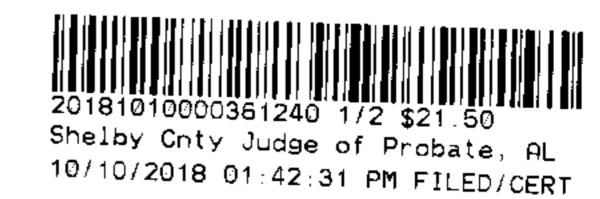
WARRANTY DEED
