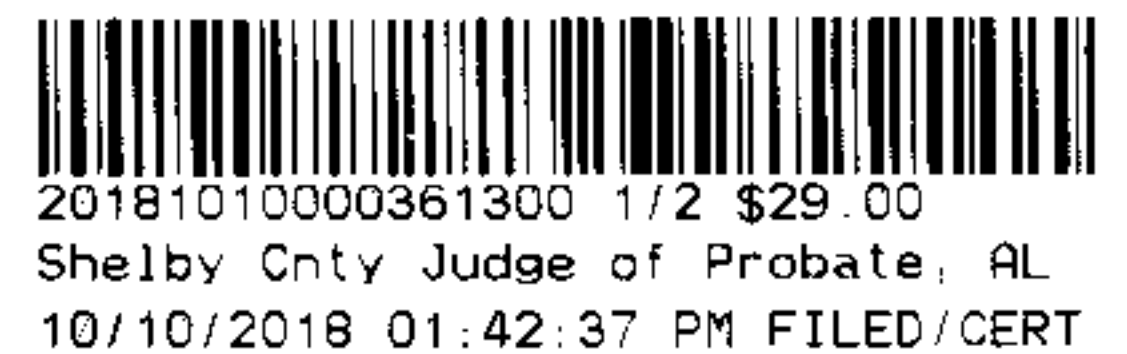

SUBJECT PROPERTY IS NO PART OF THE HOMESTEAD OF THE GRANTORS OR THEIR SPOUSES.



Subject to easements, restrictive covenants, set back lines, limitations, rights of ways as shown by public records and ad valorem taxes as shown of record.


