MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, September 15, 2012, **Sandra L. Lanzi F/K/A Sandra L. Ackley, an unmarried woman, Mortgagor**, did execute a certain mortgage to **Mortgage Electronic Registration Systems, Inc. as nominee for Branch Banking and Trust Company, its successors and assigns**, which said mortgage is recorded in Instrument No. 2012004000380920 as modified by that certain Modification Agreement in Instrument No. 20150729000259740, in the Office of the Judge of Probate of Shelby County, Alabama.; and

WHEREAS, said mortgage and the debt thereby secured was last transferred and assigned to **Branch Banking and Trust Company**, as transferee, said transfer is recorded in Instrument 20170105000005480, aforesaid records, and Branch Banking and Trust Company, is now the holder and owner of said mortgage and debt; and

WHEREAS, default was made in the payment of indebtedness secured by said mortgage, and the said Branch Banking and Trust Company did declare all of the indebtedness secured by said mortgage due and payable and did give due and proper notice of foreclosure of said mortgage, in accordance with the terms thereof, by First Class Mail and by publication in the Shelby County Reporter, a newspaper of general interest and circulation in Shelby County, Alabama, in its issues of 08/01/2018, 08/08/2018, 08/15/2018; and

WHEREAS, on September 24, 2018, the day on which the foreclosure sale was due to be held under the terms of said notice at 12:45 o'clock am pm, between the legal hours of sale, said foreclosure was duly and properly conducted and Branch Banking and Trust Company did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Columbiana, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of Branch Banking and Trust Company in the amount of **ONE HUNDRED TWENTY-NINE THOUSAND SIX HUNDRED DOLLARS AND NO CENTS (\$129,600.00)** which sum the said Branch Banking and Trust Company offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said Branch Banking and Trust Company; and

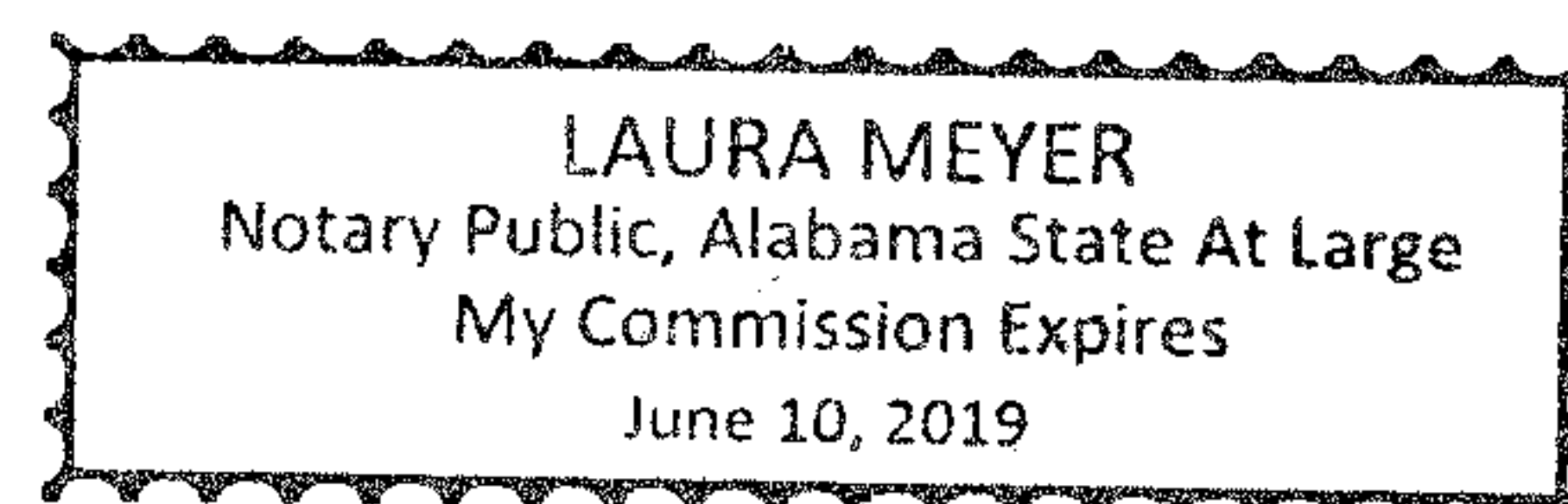



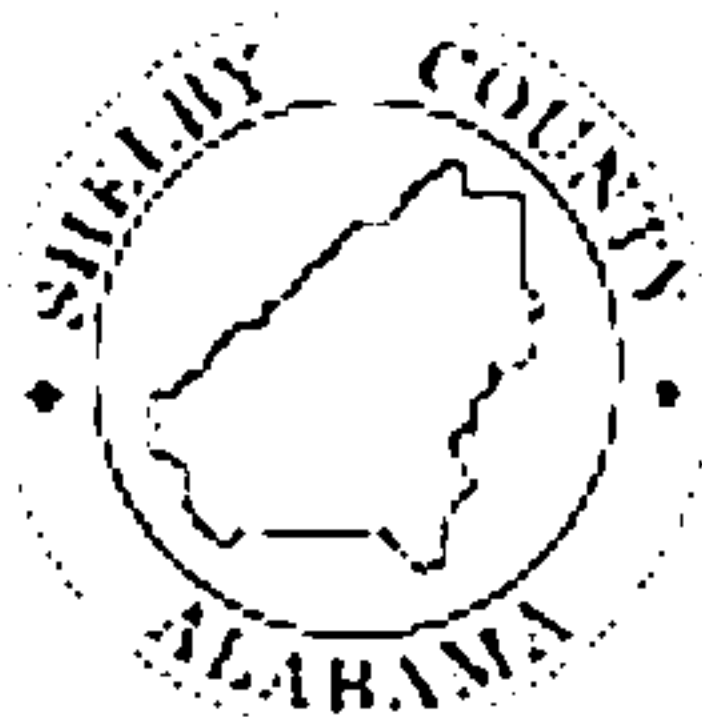
