FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on November 4, 1992, to-wit: Eny L. Garner, a single person, executed a mortgage to the United States of America, acting through the Farmers Home Administration, United States Department of Agriculture, herein called the Mortgagee, which said mortgage was recorded on November 9, 1992, in Instrument No. 1992-26126, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; and

WHEREAS, the said mortgage provides that if said indebtedness or any part thereof should remain unpaid at maturity, then the whole of indebtedness shall at once become due and payable and said mortgage be subject to foreclosure, and further provides that in the event of any such default the Mortgagee or its assigns shall have the authority to sell said property before the Courthouse door in the City of Columbiana, County of Shelby, State of Alabama, at public outcry for cash after first giving notice by publication once a week for three successive weeks of the time, place and terms of said sale in some newspaper of general circulation published in Shelby County, Alabama, and further provides that in the event of any such sale the person conducting such sale shall have power and authority to execute a deed to the purchaser of said property at such sale, and further provides that the Mortgagee or its assigns may bid and become the purchaser at such sale of the property therein; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and thereafter notice was published in The Shelby County Reporter, a newspaper of general circulation and published in Shelby County, Alabama, on August 29, 2018, September 5, 2018, and September 12, 2018, that the hereinafter described property would be sold before the courthouse door of the Shelby County Courthouse at Columbiana, Alabama, at public outcry to the highest bidder for cash, within the legal hours of sale on October 2, 2018, and

WHEREAS, the said sale was held at the time and place stated in said notice, in strict conformity with the powers of sale contained in the said mortgage, at which sale Rural Housing Service, U.S. Department of Agriculture, became the purchaser of the hereinafter described property at and for the sum of \$59,231.00, cash, which was the highest, best, and last bid therefore; and

WHEREAS, the undersigned, Michael Corvin, conducted said sale and acted as auctioneer thereat, under and pursuant to an appointment as such by The United States of America, acting by and through the United States Department of Agriculture;

NOW THEREFORE, IN consideration of the premises Eny L. Garner, a single person and The United States of America, acting by and through the United States Department of Agriculture, both acting by and through the undersigned as their duly constituted and appointed attorney-in-fact and auctioneer at said sale, do hereby grant, bargain, sell and convey unto the said Rural Housing Service, U.S. Department of Agriculture the following described real property situated in Shelby County, Alabama, at 121 Shaw Villa, Montevallo, AL 35115, but in the event of a discrepancy, the legal description shall control to-wit:

Lot 10, according to the Survey of Shaw Villas Phase 2 as recorded in Map Book 14, Page 115 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

TO HAVE AND TO HOLD unto Rural Housing Service, U.S. Department of Agriculture, its successors and assigns forever, as fully and completely in all respects as the same could or ought to be conveyed to the said Rural Housing Service, U.S. Department of Agriculture, under and by virtue of the power and authority contained in the aforesaid mortgage. Subject, however, to the statutory rights of redemption on the part of those entitled to redeem as provided by the laws of the State of Alabama, also subject to prior liens, ad valorem taxes, easements and restrictions of record.


