WHEREAS, heretofore, on, to-wit: the 13th day of October, 2005, Katherine L. Moore aka Katherine L. 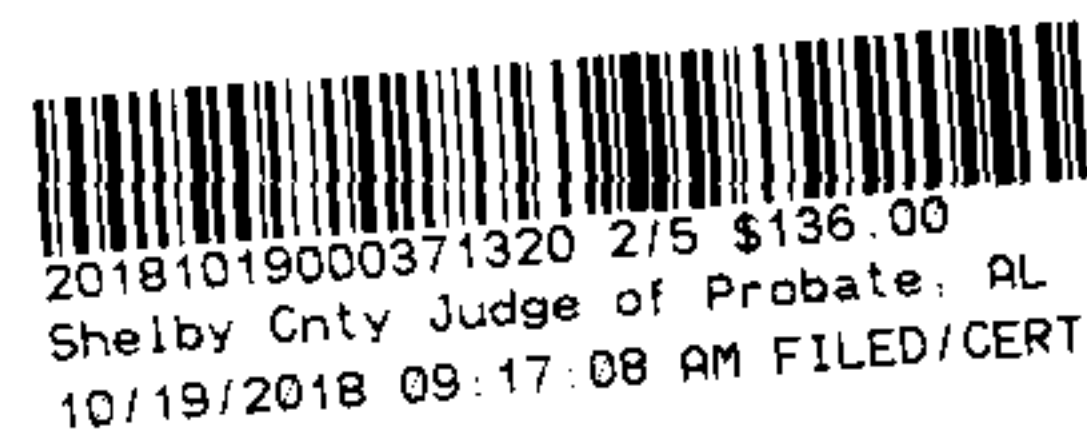

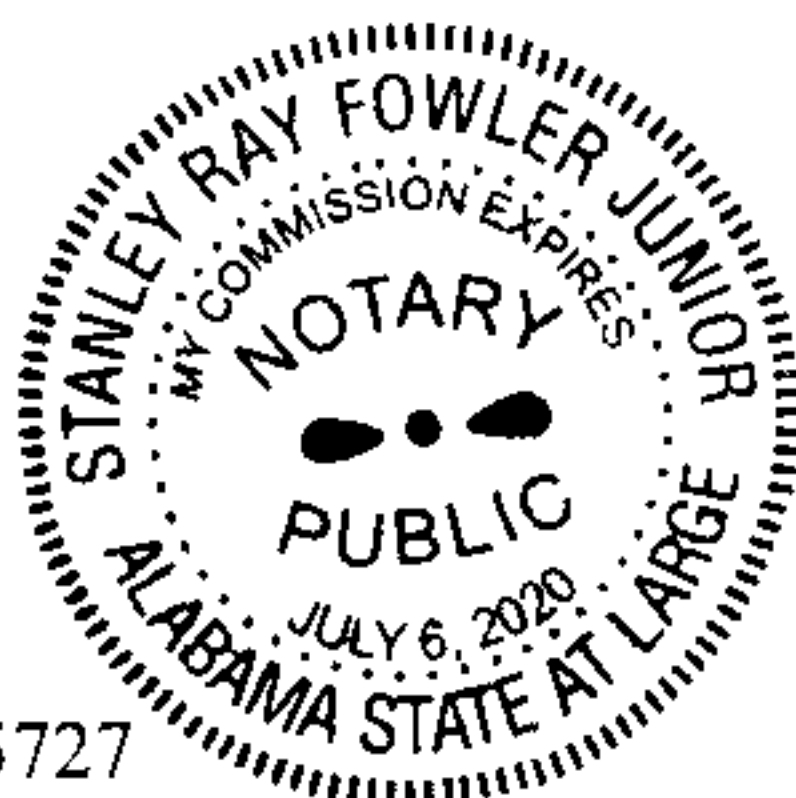


