Porter**, a married man (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **William Ingram and Teresa Lynn Ingram**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

The East 1/2 of the SE 1/4 of the NW 1/4 of Section 4, Township 24 North, Range 15 East. All being situated in Shelby County, Alabama.

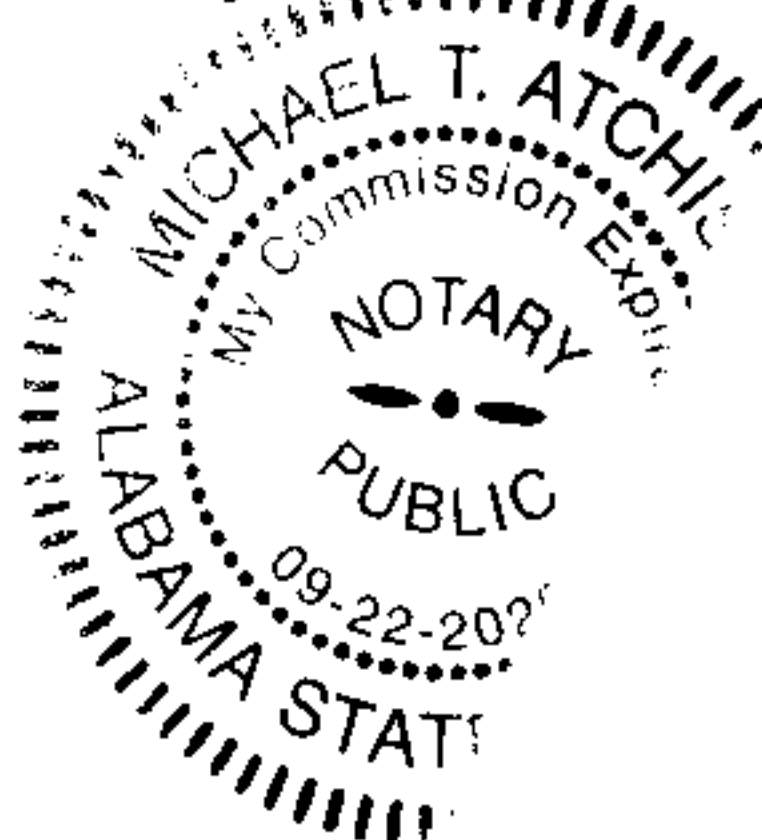
