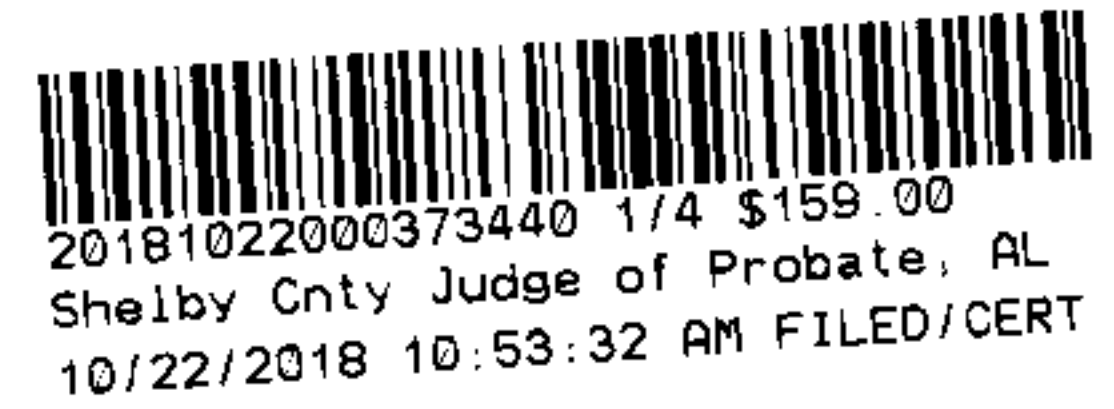

**ARTICLES OF ORGANIZATION
OF
BILLY'S EXCAVATING, LLC.**



Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama legislature of the Alabama Limited Liability Company Act ("Act"), the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

ARTICLE I

Name

The name of the limited liability company ("Company") is **BILLY'S EXCAVATING, LLC.**

ARTICLE II

Duration

The Company shall be dissolved, and its affairs wound up, upon the occurrence of the first of the following events:

- (i) the unanimous written consent of the Members to dissolve the Company;
- (ii) an event of dissociation of a member pursuant to Section 10-12-36 of the Act, unless there are at least two Remaining Members (or at least one Remaining Member and a new Member is admitted) and the legal existence and business of the Company is continued by unanimous consent of the Remaining Members within ninety (90) days thereafter;
- (iii) when the Company is not the successor in a merger or a consolidation of the Company with one or more entities; or
- (iv) upon the entry of a decree of judicial dissolution pursuant to Section 10-12-38 of the Act.

ARTICLE III

The purposes for which the Company is formed are as follows:

- (a) To operate a business for the purpose of hauling rock, sand, dirt, etc.
- (b) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.

ARTICLE IV
Registered Agents and Office

The address of the Company's initial registered office in Alabama is **812 Coby Lane Columbiana, Alabama 35051**. The name of the Company's initial registered agent at that address is Willie M. Thomas, Jr.

ARTICLE V
Initial Members

The names and address of the Company's member is::

ARTICLE VI
Management

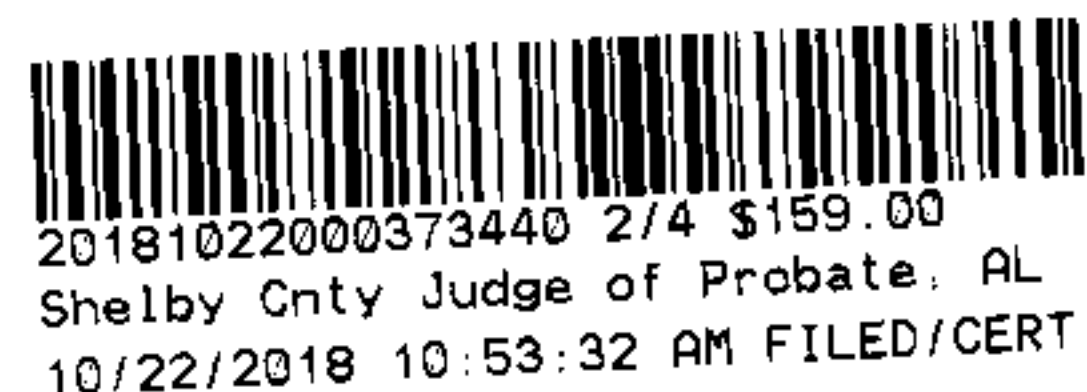
The Company is to be managed by all members, Willie M. Thomas, Jr.

ARTICLE VII
Admission of New Members

Members of the Company have the right to admit new members on the unanimous written consent of the existing members. The existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.


ARTICLE VIII

The remaining members of the Company shall have the right to continue the business after an event or dissociation terminates the continued membership of a member in the Company on the unanimous written consent of the remaining members.

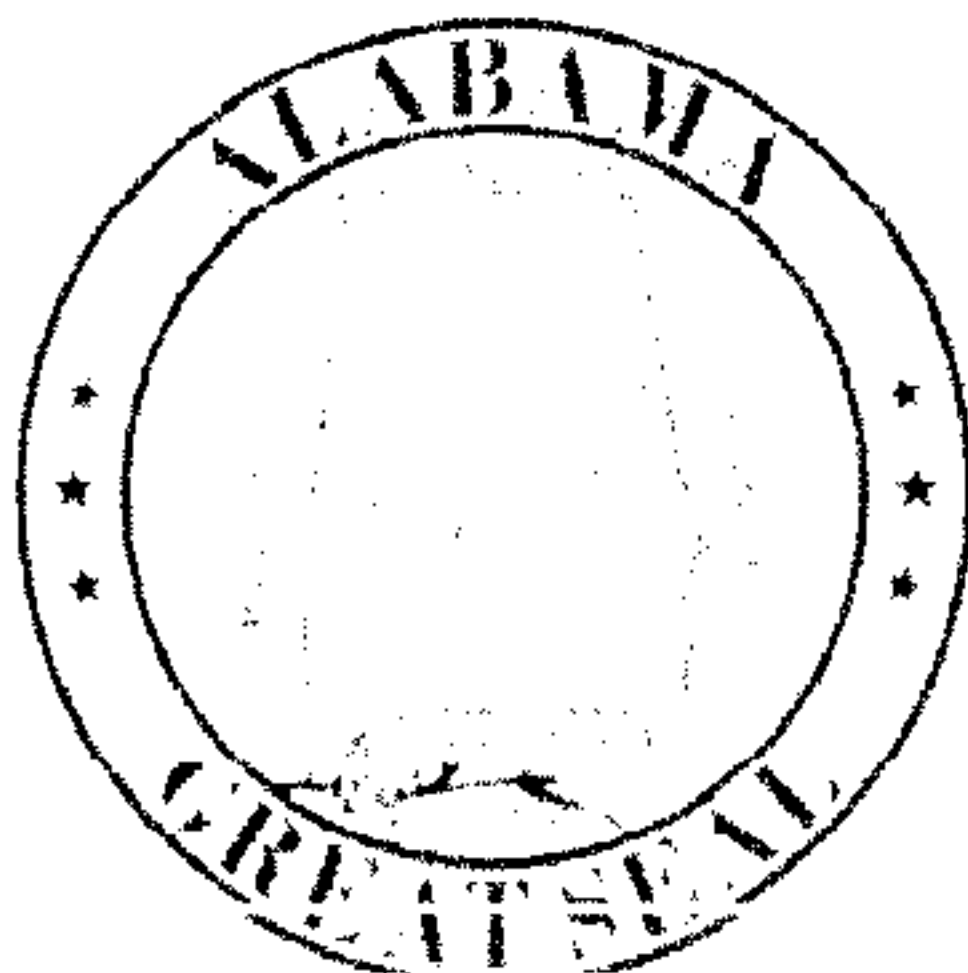
