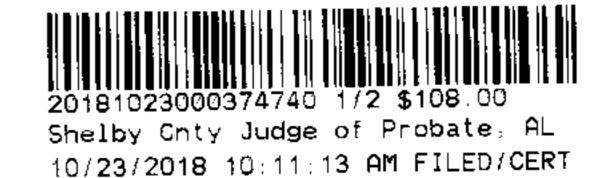
WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Ninety Thousand and 00/100 (\$90,000.00) and other valuable considerations to the undersigned Grantor(s) in hand paid by the Grantee(s) herein, the receipt of which is hereby acknowledged, I/we JAMES KIRKWOOD, A MARRIED INDIVIDUAL herein referred to as Grantor(s), do hereby GRANT, BARGAIN, SELL AND CONVEY unto JUSTIN PHILLIP **LAFFERTY**, referred to as Grantee(s), his/her/their heirs and assigns, the following described real estate, situated in Shelby County, State of Alabama, to wit:

A PARCEL OF LAND SITUATED IN THE NW 1/4 OF THE NE 1/4 OF SECTION 13, TOWNSHIP 19 SOUTH, RANGE 2 WEST, SHELBY COUNTY, ALABAMA AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCE AT THE NW CORNER OF THE NW 1/4 OF THE NE 1/4 OF SECTION 13, TOWNSHIP 19 SOUTH, RANGE 2 WEST, SHELBY COUNTY, ALABAMA; THENCE S 87 DEG. 34' 01" E A DISTANCE OF 787.18' TO THE POINT OF BEGINNING; THENCE CONTINUE S 87 DEG. 34' 01" E A DISTANCE OF 210.20' TO A POINT ON THE WESTERLY RIGHT-OF-WAY OF ALABAMA HIGHWAY 119; THENCE S 41 DEG. 06' 06" W ALONG SAID RIGHT OF WAY A DISTANCE OF 29.43' TO THE POINT OF A CURVE TO THE LEFT HAVING A RADIUS OF 2904.78', A CENTRAL ANGLE OF 03 DEG. 34' 11" AND SUBTENDED BY A CHORD WHICH BEARS S 38 DEG. 45' 15" W, A CHORD DISTANCE OF 180.95'; THENCE SOUTHWESTERLY ALONG SAID CURVE AND RIGHT-OF-WAY AN ARC DISTANCE OF 180.97'; THENCE N 87 DEG. 28' 38" W A DISTANCE OF 210.04'; THENCE N 39 DEG. 06' 02" E A DISTANCE OF 210.00' TO THE POINT OF BEGINNING.
