LESS AND EXCEPT land conveyed in Inst. No. 2002-2542 recorded in Probate Office, Shelby County, Alabama.

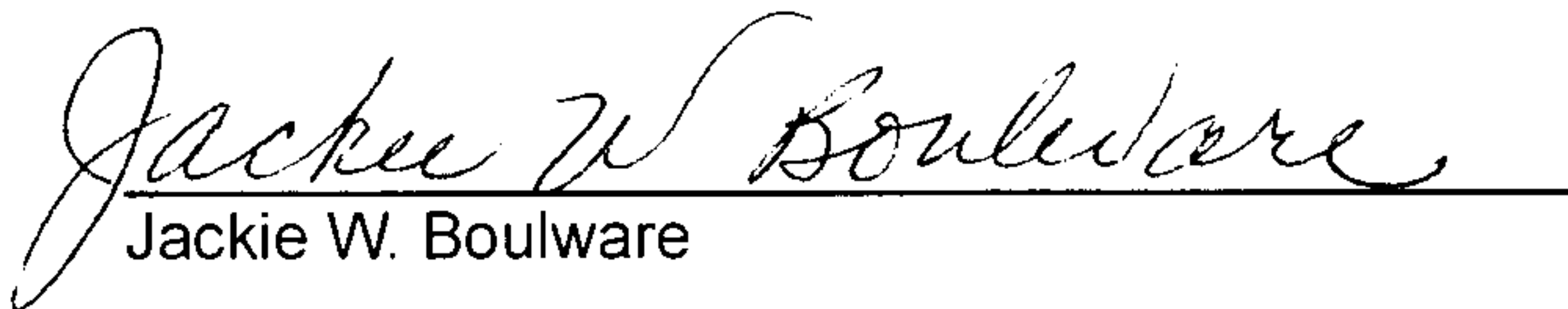

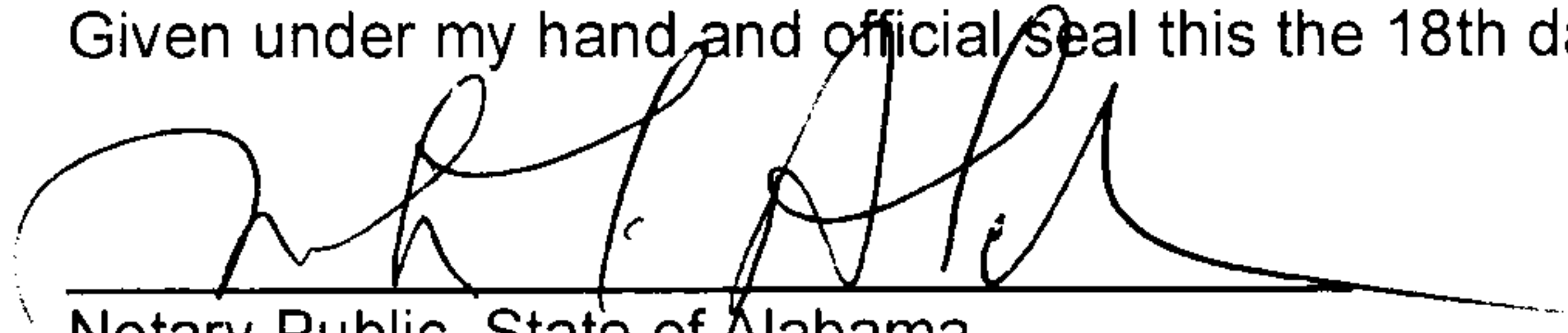
