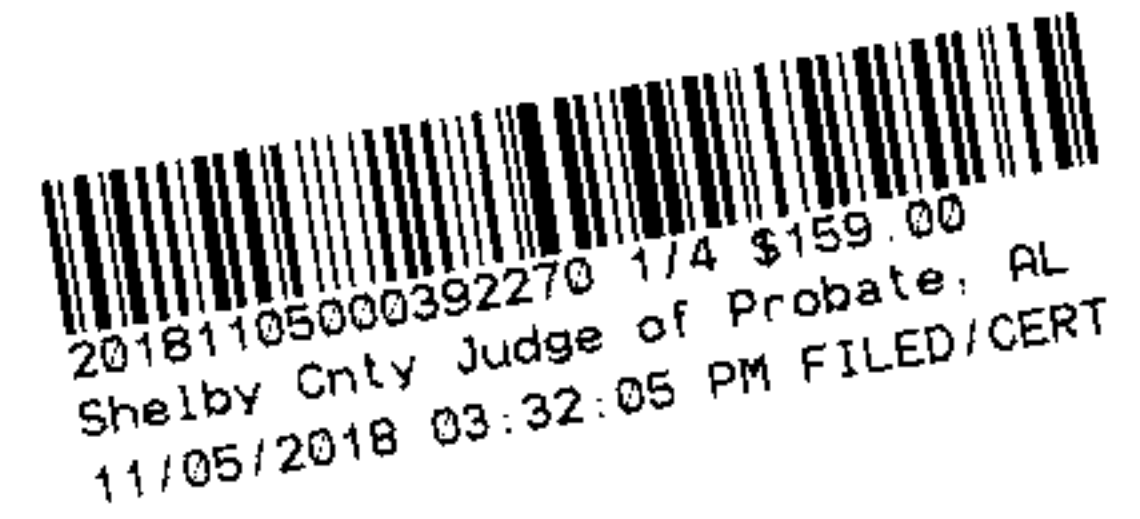


ARTICLES OF ORGANIZATION
OF

The undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I
NAME

The name of the limited liability company is J. Jireh, LLC.

ARTICLE II
DURATION

The period of duration is perpetual.

ARTICLE III
PURPOSES

The Limited Liability Company has been organized for the following purposes:

1. To engage in the activity of sales; and
2. The transaction of any or all lawful business which may be incidental or beneficial to the company.

The initial members shall have the right to admit additional members upon unanimous consent and agreement of the original members.

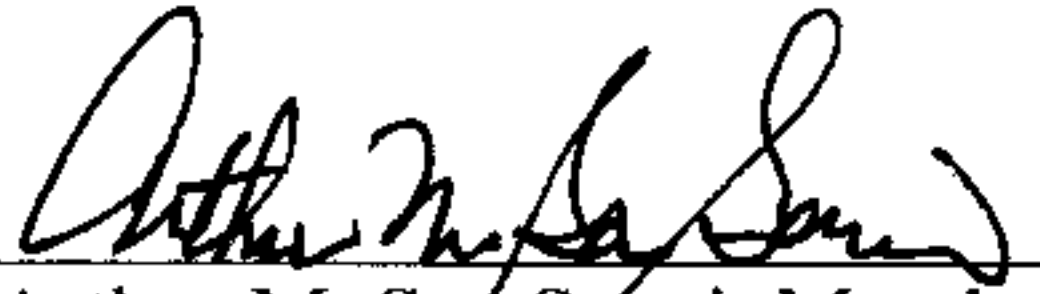
**ARTICLE IX
