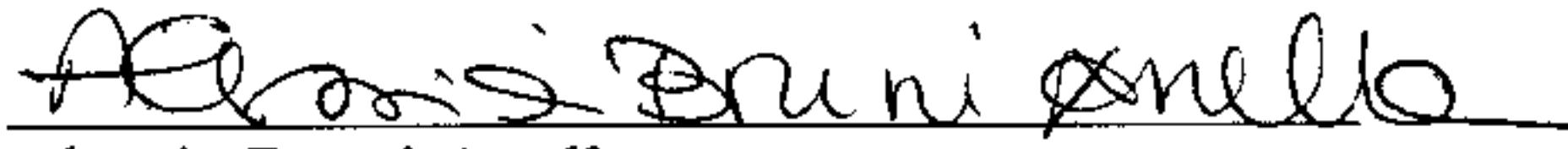

The formation of the Company is effective immediately on the date that the Certificate of Formation for the Company is filed with the Office of the Judge of Probate of Shelby County, Alabama.

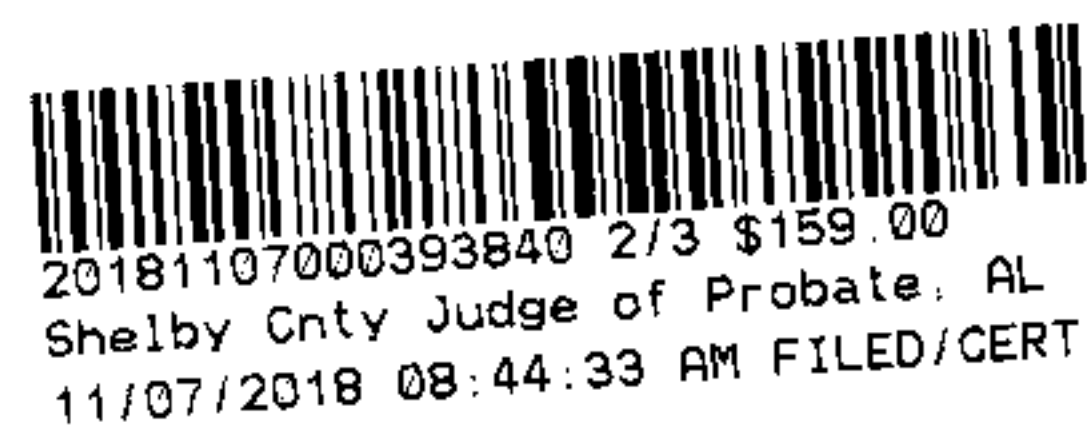
