FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 15th day of August, 2013, Wayne E Jackson Jr, Temyia S Jackson, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for SunTrust Mortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20130826000349260, said mortgage having subsequently been transferred and assigned to Bayview Loan Servicing, LLC, by instrument recorded in Instrument No. 20180207000041040, in the aforesaid Probate Office ("Transferee"); and

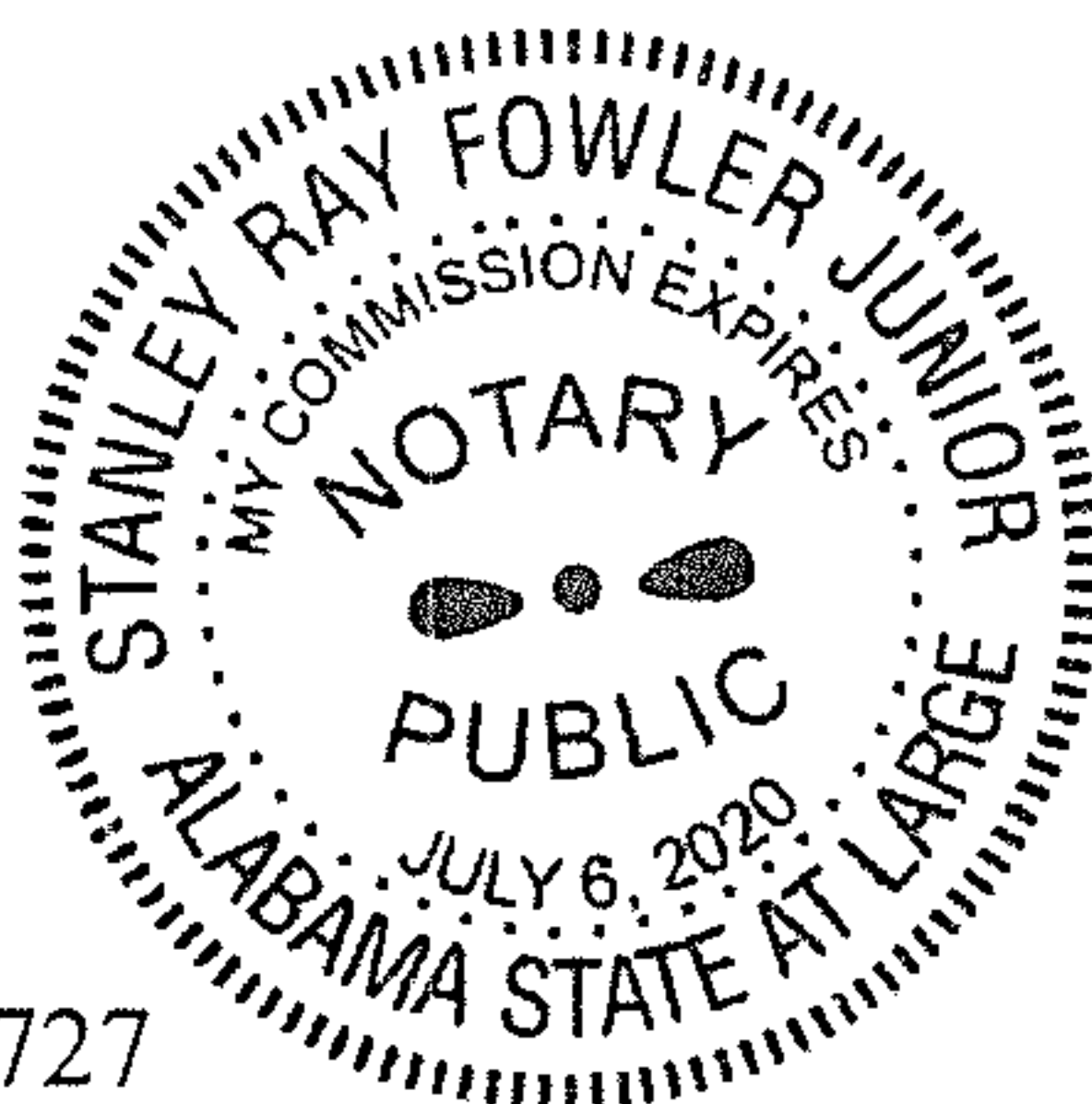
