That for and in consideration of **FIVE HUNDRED SIXTY NINE THOUSAND NINE HUNDRED AND NO/100 (\$569,900.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **JOEL RIVERA and MARIE RIVERA**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the GRANTEE, **LISA M. DENNIS**, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Marie Rivera and Maria Rivera are one and the same person.

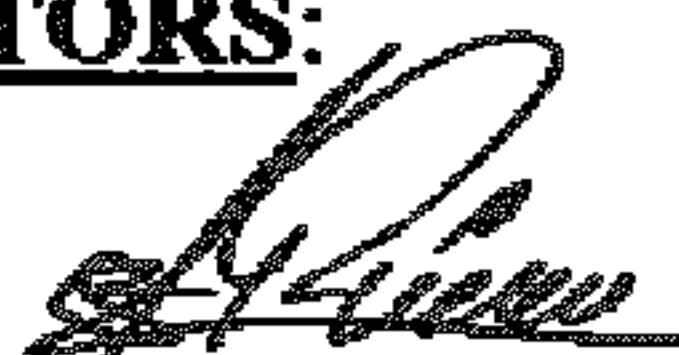
The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.

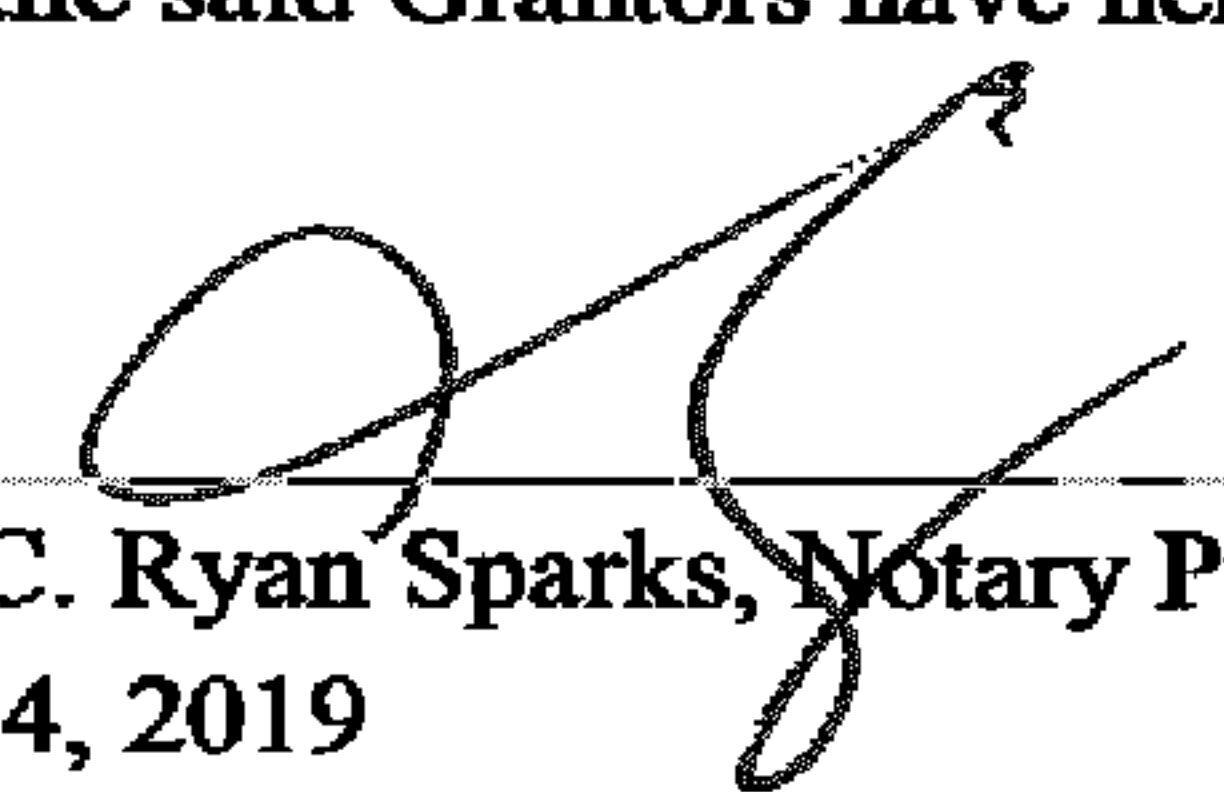
