Subject to easements, restrictions, rights-of-way, setback lines, covenants, agreements, and mineral/mining rights, if any, of record.


\$150,000.00 of the above-recited purchase price is being paid in cash.

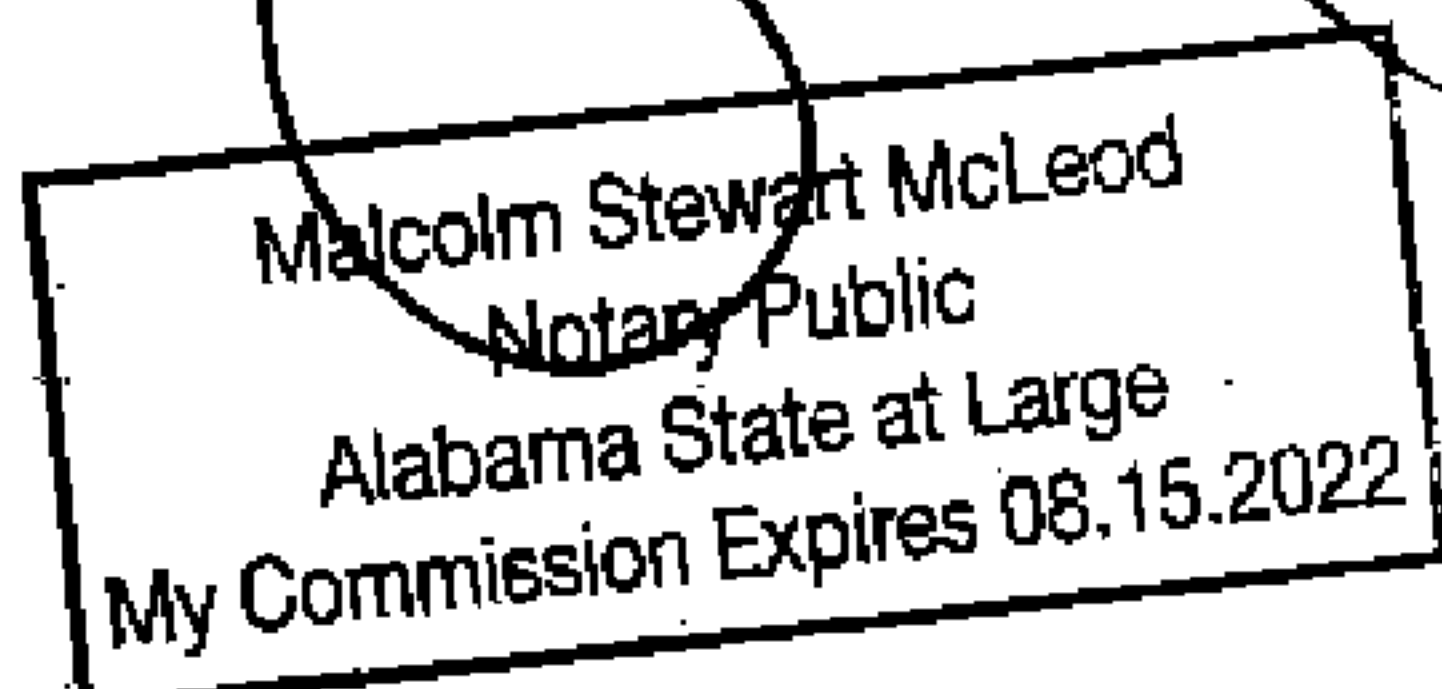

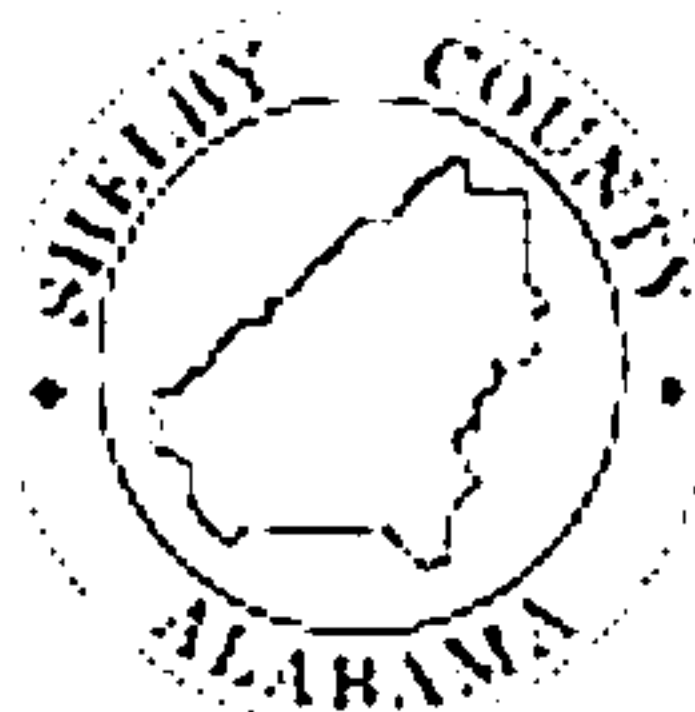
