PURPOSE: In order to form a Nonprofit Corporation under Section 10A-1-3.05 and 10A-3-3.02 of the Code of Alabama 1975 this Certificate Of Formation and the appropriate filing fees must be filed with the Office of the Judge of Probate in the county where the corporation's initial registered office is located. **The information required in this form is required by Title 10A.**

INSTRUCTIONS: Mail one (1) signed original and two (2) copies of this completed form and the appropriate filing fees to the Office of the Judge of Probate in the county where the corporation's registered office is/will be located. Contact the Judge of Probate's Office to determine the county filing fees. **Make a separate check or money order payable to the Secretary of State for the state filing fee of \$100.00** and the Judge of Probate's Office will transmit the fee along with a certified copy of the Certificate to the Office of the Secretary of State within 10 days after the Certificate is issued. Once the Secretary of State's Office has indexed the filing the information will appear at www.sos.alabama.gov under the Government Records tab and the Business Entity Records link – you may search by entity name. Your notification of filing was provided by the Probate Judge's Office via a stamped copy and the Secretary of State's Office does not send out a copy. You may pay the Secretary of State fees by credit card if the county you are filing in will accept that method of payment (see attached). Your corporation will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored.

ARTICLES OF INCORPORATION OF CUMBERLANDO PRESBYTERIAN CHURCH ROCA DE SALVACION

The undersigned incorporators adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

Cumberland Presbyterian Church Roca de Salvacion.

ARTICLE II PRINCIPAL OFFICE

The corporation's initial registered office shall be in Jefferson County, Alabama. The street address of the initial registered office is:

2404 Altadena Rd Birmingham, Alabama 35243

ARTICLE III PURPOSE

The corporation is a Nonprofit Religious and Charitable Corporation. The corporation is formed exclusively for religious and charitable purposes within the meaning of Section 501c(3) of the Internal Revenue Code. No part of the net earnings of the corporation shall inure to the benefit of or be distributable to the directors, officers, members, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments or distributions in furtherance of its religious or charitable purposes. The assets of the corporation shall be dedicated to the religious and charitable purposes of the corporation. Upon dissolution of the corporation, the assets shall be distributed to Grace Presbytery of the Cumberland Presbyterian Church if that organization is then a tax-exempt organization within the meaning of Section 501c(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code; or otherwise to one or more such tax-exempt organizations as may be designated by Grace Presbytery of the Cumberland Presbyterian Church.¹

ARTICLE IV MANNER OF ELECTION

The directors of the corporation, who shall be called "Elders," shall be selected in the manner provided in bylaws adopted by the corporation.

ARTICLE V INITIAL DIRECTORS AND/OR OFFICERS

The number of Directors constituting the initial Board of Directors is six. Below are the names, specific titles and addresses.

¹ This provision is required in order for the corporation to be recognized by the Internal Revenue Service as a tax-exempt organization described in § 501(c)(3) of the Internal Revenue Code.
